Dear government and school officials,

After many months of health mandates being forced on our own children and our local community children, we need you to understand that we've had enough. It's time to return control back to local government, back to the local schools, and back to the local parents. As concerned parents, as concerned citizens, and as the people of Union County, in whom the power of our government resides, we need you to understand our stance as outlined below:

- We demand medical freedom for our children. We will not tolerate medical mandates any longer.
- We will not tolerate the forced masking of our children any longer. The highest level of medical evidence is meta-analysis of multiple randomized control trials. Without an exception all the studies done at this high-level show that masks show no statistical significance in preventing the spread of respiratory viruses. Are the studies that purport to support mask effectiveness done at the same high-level? Either way, we have conflicting data and proving effectiveness is not enough, we must prove safety, and no long-term safety studies have been done with children. We have grave concerns about the damage these masks are inflicting on our children's psychological and physiological health. Masks must be made optional. The decision to mask a child must be the parent's decision alone.

- We do not consent to our children being part of the COVID "vaccine" trial. There is no long-term safety and
