# SHOW RULES & REGULATIONS

The parties agree that in the event of breach of contract the actual damages would be difficult to determine and that in the event of refusal or failure to pay said balance according to the terms above the Nonrefundable deposit may be retained as liquidated damages, or in the alternative, said **Northern Minnesota Craft and Vendor Expo, Inc.** may proceed to enforce this contract and receive the balance owing under this contract.

All rules and regulations governing the above show, are accepted by us, and made part of this contract, and we agree to comply with all of them, taking the space for exhibiting purposes under the terms and upon the conditions set forth in the rules and regulations.

**Northern Minnesota Craft and Vendor Expo, Inc.** agrees to give us the use of this space, to be used by us in consideration and for the purposes and time aforesaid.

1. All space contracts are non-cancelable and non-transferable. Exhibitor cannot sublet space or hand out literature or display product belonging to a person or business that is NOT exhibiting at the Northern Minnesota Expos. Exhibitors must restrict their displays to the space contracted for. Exhibitors may not use the aisles in any way to conduct sales. Additionally exhibitor is prohibited from distributing or promoting any other expo or event construed as being in direct competition with the Northern Minnesota Expos. Any Exhibitor doing so will be asked to stop immediately. Violation of policy could mean expulsion from the Show without a refund of Exhibitor fees. The coordinators reserve the right to move any exhibit.
2. Exhibitors must agree to set up exhibits and displays in keeping with the high standards of the show.
3. All displays, and exhibits must comply with all the rules and regulations of the local Fire and Health Department. Fire exits and alleys must be kept open at all times.
4. All booths must be manned at all times the show is open.
5. In case the premises are destroyed by fire or the elements, or by any other causes, or in case any circumstances whatsoever, including strikes or storms shall make it impossible for the Management to permit any Exhibitor or Exhibitors to occupy the premises, Northern Minnesota Craft and Vendor Expo, Inc. is released from any and all claims for damage which might arise in consequence thereof.
6. In the event the show is not held Northern Minnesota Craft and Vendor Expo, Inc. are released from any and all claims for damages upon refunding of all monies received from an exhibitor or exhibitors.
7. Should inclement weather fire, floods, embargoes, war, acts of war, insurrections, riots, strikes, lockouts or other labor disturbances, or acts of God and or pandemic force the producer to postpone and reschedule the show, all fees paid will be transferred to the reschedule date. No exceptions.
8. The show may be delayed in the event of the occurrence (certified by the United States Centers for Disease Control or successor body) of a widespread viral infection transmitted via bites or contact with bodily fluids that causes human corpses to reanimate and seek to consume living human flesh, blood, brain or nerve tissue and is likely to result in the fall of organized civilization.
9. Exhibitors **MAY NOT** begin dismantling their booth until the posted time of show closing. Early move out is strictly prohibited.
10. No sign or other articles may be fastened to walls, electrical fixtures or booth pipe and drapes. The use of tacks, tape, nails etc that would mar the floors or walls is prohibited.
11. **Northern Minnesota Craft and Vendor Expo, Inc.**, coordinators, building management and officers thereof, those managing the show on neither their behalf nor their employees will be responsible for any loss or damage that may arise to the exhibitor, employees of, or their goods either while in transit to or from the building or while in the building from any cause whatsoever.
12. The coordinators must approve any exhibit over eight (8) feet in height. Request must be specified on this contract.
13. All exhibitors must return a completed Minnesota Revenue Department ST-19 Sales & Use tax information form. Failure to return the ST-19 will result in not being allowed to set up your booth and participating in the show.
