### DIRECTIONS:

**From North or South:** Take CA 99 to Madera. Exit on Cleveland Avenue and go west. Just past Panda Express and the Grocery Outlet, turn left on Schnoor Avenue. Continue past the first stop sign. With Lowe’s on your right, turn left into the Fairgrounds. You may park and set up easy ups on the north and west sides of the ring. RVs with hookups will be assigned to set up by the trees on the east side of the ring. RVs without hookups and tent campers may set up on the north side of the entry road.



**CONFIRMATIONS** of the classes you entered will be Emailed to all entrants who provide a valid email. **PLEASE READ YOUR CONFIRMATIONS!!** General information will be Emailed about a week before the trial with check-in time, walk-through/start times, and tentative class running orders.

**CLASS CHANGES:** Moveups must be submitted in writing (Emails OK) and must be received by the Trial Secretary before **5:00 PM Friday, March 31, 2023**. Moveups will be allowed at the trial from Saturday to Sunday – The moveup form will be posted at the score table. All move-up requests must be on the form within 30 minutes after the last class has finished on Saturday. NO Exceptions!

**ACE PROGRAM:** ASCA has two programs, ACE and Championship. Dogs entered in ACE jump 4" lower than their CH STD jump height and get a bit more time. It's similar to USDAA or AKC performance. ACE dogs are not included in ASCA Finals. **Dogs may be entered only in Championship or ACE.** ACE has a Standard Division and a Senior Dog Division. See the latest ASCA Agility Rule Book at [www.asca.org](http://www.asca.org) for more details.

**FEO:** Dogs 15 months or older can be entered For Exhibition Only. Dogs less than 18 months of age will jump the next lower jump height than their regular height. Dogs must be entered FEO on their entry form and cannot switch to a regular CH or ACE class at the trial. FEO dogs will be scored by the judge like other dogs. If the dog completes the course, a time and any faults will be given but qualifying runs do not apply. If the dog does not complete the course, it may be eliminated for "training in the ring."

**TOYS IN THE RING:** Toys will be allowed in the ring for training (no squeaky toys and no toys with food). Handlers using toys will run in their regular order. Mark a "T" on the gate sheet to indicate you will be using a toy. When you enter the ring, show the judge your toy.

**NOVICE A or NOVICE B:** Novice A is for dogs, owners and handlers who have never earned an agility title in any agility organization.

**AWARDS:** CVASC offers ribbons for First through Fourth place in each class for each jump height division. 20+" and 24" dogs will be scored together. ASCA green Qualifying Ribbons will be offered to every dog obtaining a qualifying score. Dogs that complete an ATCH/ACE receive a large rosette and a decorated pole for signing. Please let us know if you are close to your ATCH/ACE.

**HIGH IN TRIAL AWARDS** will be awarded to the highest scoring dog(s) in the following categories (6 awards in all): Rosettes to HIT in the Novice, Open and Elite levels (CH Standard division), Junior CH division, Veteran Dog CH Division and overall ACE. A dog's category will be based upon the level/division in which the dog competes in its last Regular class. All Qs are counted. Qs receive 5 points for Novice, 6 points for Open and 7 points for Elite. Faulted Qs received ½ the value. High point dog in each category is the winner. The average YPS in Regular is the tie breaker

**EQUIPMENT LIST:** Rubberized 5'6" Aframe and 12' dog walk, both with rubberized and slatted contacts. Rubberized teeter. Jumps, tunnels, 24" weave poles, displaceable tire. Electronic timing will be used.

**FOOD:** There will be a complimentary continental breakfast. Lunch will be provided for volunteers who work at least 2 classes per day.

### **RVs/On-site Camping**

20 RV spaces with power, water, and sewer hookups are available on a first come first served basis. Cost is \$40 per night. RVs with no hookups and tent camping is \$30 per night. Complete and return the RV reservations form with your entry.

**ASCA Service Membership and QT Number** - In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA QT Number. **This is a one-time fee of \$20/dog.** At the time of applying for the QT number, **the individual owner and all owners or co-owners must also be ASCA members** (minimum membership type of 'Service' is required). ASCA membership does not need to be maintained in subsequent years. It will be the responsibility of the owner/s to identify previous ASCA points earned when applying for a QT Number.

**PERMANENT MEASUREMENT CARDS** – Dogs with a standard jump height of 20+" or greater do not need to be measured. All other heights must be measured or you must present an ASCA, NADAC or AKC permanent height card, or USDAA website printout of dog's measurement for a permanent jump height card. Copy of permanent jump height card can be sent with entry.

**JUNIOR HANDLERS:** Junior Handlers are under 18 years.

## NOTICE TO ALL EXHIBITORS

This trial will be held under the current rules and regulations of ASCA. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial. A copy of ASCA's Agility Rulebook may be downloaded free from the ASCA web site: [www.asca.org](http://www.asca.org).

No entry shall be accepted from a dog or handler disqualified from the ASCA agility or all ASCA programs; or a member/person not in good standing with ASCA. The Trial Committee may refuse any entry on the basis expressly provided through ASCA rules and regulations or guidelines established by the ASCA Board of Directors.

Safety shall always be the foremost consideration in actions and conduct by handlers at all times. In all cases, regardless of the situation, the judge's decisions are final.

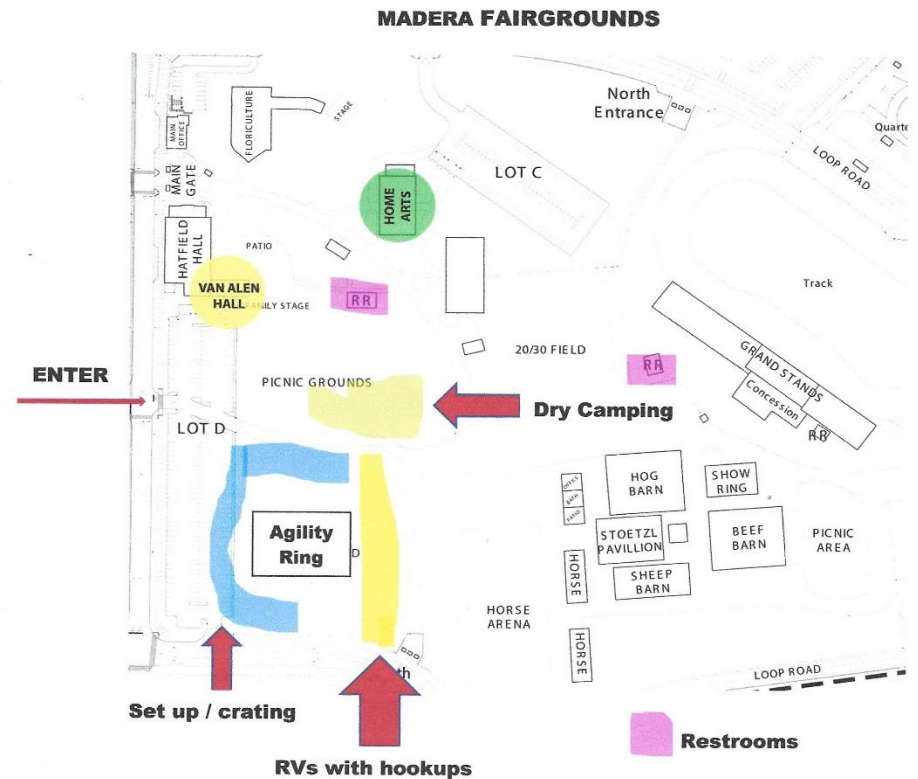
**Refunds:** No refunds are given for entries withdrawn after the closing date. No refund is given if a dog or handler is dismissed from competition, regardless of the reason. No refund is given if the trial cannot open or be completed due to riots, civil disturbances, fire, acts of God, public emergencies, acts of a public enemy, or any other cause beyond the Show Committee's control. The show will not be cancelled in the event of rain. Refunds of 50% of the entry fees paid will be issued for injured dogs or bitches in season if submitted to the trial secretary in writing by 8 a.m. on Saturday before the trial. A letter from your vet indicating the dog's condition may be requested in order to process the refund.

No set up within 15' of the ring. All dogs must be on leash when not competing. **Please clean up after your dog!**

Please keep hotel rooms and premises clean so hotels continue to accept dogs.

The Trial Committee will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause.

It is distinctly understood that every dog at this event is in the care, custody, and control of his/her owner or handler during the entire time the dog is on the show premises. Please take responsibility for your dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave. There will be no refunds for entries if a dog or handler is dismissed from competition for any reason.
