Trial #2: Will begin approximately 30 minutes after the end of Trial #1

but no earlier than 11:30 a.m.

DIRECTIONS, SET UP, AND PARKING: From the south: Take Freeway 99 to Freeway 198 and go west. Take the 10th avenue off ramp. At the first stop light, turn left over the freeway. Fairgrounds will be on your left. **From the north:** Take Freeway 99 to Highway 43 south to Hanford. Continue to 10th Avenue. The Fairgrounds will be on your left. **From I5 north or south:** Take I5 to Freeway 198 east to the Central Hanford off ramp. Take the frontage road east to 10th avenue. Go right. The Fairgrounds will be on your left. (See Fairgrounds map on next page).

Fairground gates open at 7:00 a.m. for exhibitor access and set up. The gates close at 6:00 p.m. or a half hour after Trial #2, whichever is later.



WILDCARD CLASSES OFFERED: Wildcard classes will be offered for all regular Obedience classes. Dogs can enter any Wildcard class without having to complete lower level ASCA titles. For example, an AKC Utility dog with no ASCA titles doesn't have to enter the Novice class. The dog can enter the Wildcard class in Utility to practice any exercises desired. - 2. No entry shall be accepted from a dog or handler disqualified from the ASCA Obedience and/or Rally program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.
- 3. Bitches in season are not allowed to compete.
- 4. No entry fees will be refunded after the close of pre-entries. Returned checks do not constitute a valid entry. There is a \$35 service charge for returned checks.
- 5. These trials will be held under the current rules and regulations of ASCA.

- 7. This ASCA Rally and Obedience trial is open to all breeds, including mixed breeds, with an ASCA Registration or ASCA QTracking number. We will have forms available at the trial (so we can forward them to the ASCA office) but we encourage you to apply for a QTracking number in advance. AGREEMENT

(1) The person signing this Agreement represents being authorized to enter into it on behalf of him/herself, as well as (if different) the owner(s)/exhibitor(s)/handler(s) of the dog(s) for which an entry form is being submitted (all these parties collectively referred to herein as "Applicant"). (2) "Releasees" here collectively refers to the Australian Shepherd Club of America® (ASCA®); its affiliate clubs; and the officers and board of directors, staff, contractors, insurers, attorneys, and agents of ASCA® and of those clubs. (3) This Agreement voluntarily is entered into by Applicant in exchange for the acceptance of the associated entry form and permission to participate in related activities. (4) Applicant agrees to abide by the rules and regulations of ASCA® and any other rules and regulations applicable to this event. (5) Applicant certifies that the entered dog will not pose a hazard to people, property, stock animals, or other dogs, and further that the dog is current with rabies shots along with any other vaccinations required by its state of residence. (6) Applicant acknowledges and assumes the risks to Applicant and Applicant's dog associated with participation in the event, among which could be ones associated with poor condition of the facilities and surrounding areas; security measures or lack of them; electrical appliances; fittings; show rings; the presence of unfamiliar persons; and the presence/involvement of other animals—whether stock, dogs, or otherwise.
