## **USA Gymnastics and NAWGJ Updates for Judges**



Level 4/5 Compulsory Test—The Level 4/5 compulsory test is now available on the USAG website. You must be logged in to your profile to purchase and take the online test. You can take the open-book test up to four times in a year. NAWGJ Oregon will reimburse you one time for the cost of the test (\$25). Lisa Boylan and Chris Bowles recently shared some study tips/sheets, so study away! USA GYMNASTICS. USAG recently updated their guidance on assigning judges based on testing, so check their website for the latest info.

> **Reimbursement for Virtual National Congress and the** Compulsory Book—Your NAWGJ Oregon board voted to reimburse members for the cost of Virtual National Congress (\$100) and the Compulsory Book (\$75). Please submit your receipt and request for reimbursement to Debbie ASAP, so that we can account for the expenses this fiscal year. The deadline for submission for all reimbursements is Qctober 24, 2021.

#### **Revised Guidelines for New Judges**

As we welcome new judges to Oregon NAWGJ, the board recently revised past guidelines for new judges for practice judging. We are excited to welcome our new members, so to help get them started, here are some guidelines to help navigate the practice judging session:

A new judge for Level 4/5 will need to practice judge at least 2 different sessions (1 at each level, if possible) at one meet (minimum), judging all four events. A new optional judge will need to judge at least one session at their new rating, unless prior arrangements have been made with the State Judging Director (SJD).

If you are a first-year judge and haven't yet purchased a uniform, please wear a white top and navy pants/skirt (if you don't have navy, black pants are fine).



To be on the competition floor, you must be a USAG member and have completed all professional requirements (background check, safety certification, safe sport, etc.). We prefer that you are also a member of NAWGJ, as we assign NAWGJ members before non-members.

Prior to your practice judging session, please contact the SJD and she will work with you to contact the appropriate Meet Referee/Meet Director so that they know you will be practicing at the meet.

Oregon NAWGJ will reimburse you for gas money to/ from the meet and meals, if the meet director is unable to provide meals (many gyms provide a buffet and can accommodate an extra judge, but if they are providing pre-packaged meals, then we will pay for your meals).

Be prepared! Make sure you have all of the necessary supplies/judging forms.

When you first arrive, introduce yourself to the Meet Referee; she/he will introduce you to the other judges and Meet Director.

The Meet Referee and each subsequent head judge will work with you to make sure you are situated appropriately at the events during the meet.

Please adhere to a professional code of conduct while practice judging; while we recognize you may have many questions, it's important to let the judges do their jobs undistracted. If you have questions, hold them until the rotation has finished, until there is a break, or until the end of the meet. During the break, the judges should be able to answer your specific questions. You can also jot them down as you go along and ask them at the end of the meet.

After the meet, the Meet Referee will send the SJD an email confirming that you have successfully completed your practice judging and can be assigned to a meet!
