# SAFE RE-ENTRY TO JUDGING AND VIRTUAL JUDGING

- For each meet that is happening, will use 10 for 10 check list
- · Meg working on a prototype about how meets will be formatted
- Survey asking who is wanting to compete, 12 responded, all different responses
- · Gyms really want to have a season in some capacity

- Keep availability current in GymJas, everyone will need to be flexible
- FlypTen to be used for scoring virtual meets
- USA Gymnastics is not mandating to use FlypTen, open to other platforms
- · Needs to be documented officially and verified
- Many unknowns and considerations
- Playbook is posted on USAGymnastics
- · Virtual meets are happening in real time as opposed to routines that have been recorded then judged
- ProScore requires having two devices at least one iPad per panel
- · Judges can judge in same location to make devices accessible
- Precision streamed meet to parents using Instagram meet went smooth
- Potentially one judge panel through Level 5
- Meg when things get nailed down a little more, let's convene again so we can practice judge.
- Lisa has been in touch with Region 7 to understand how they have been operating successfully.
- Lisa reached out to Linda, 1:30pm Thursday 10/29 group of judges will do a mock meet to understand how to setup for a virtual event. Everyone can watch Thursday, and it will be recorded. Expected about 1.5 hours. Link will be sent to Deb to be sent out to all.
- Lisa suggesting a virtual Judges Open to show the clubs we can run a successful virtual meet and make a potential fundraiser
- · Katrina reminding everyone that the season will be fluid.
- · Please let the gyms know that the more info the assigners have the better
- Judges communicate with the assigners so they have a good understanding of your comfort level, etc.
