OR NAWGJ FUNDRAISER

- Deb to get feel about meet fundraiser before scheduling meeting Sunday, 6/14
- Possibly do a January meet and split proceeds with a gym
 - gyms will need all profits to help their gyms succeed.
- · We might be able to skip a year of fundraising with account so stable
 - \$48,000 in account
 - No cost to send Deb to 2020 SJD meeting, next year's will be in Seattle so will be cheap
 - Reduce expenses, conservative spending
- · Possible spring fundraiser not gym related
 - Sara proposes not doing a meet and doing silhouettes for water bottles, etc.
- Katrina suggests looking into spring, maybe with Xcel or compulsory.
- Chris suggests we might make sure we have a slot reserved since we just don't know what to expect for the upcoming seasons.

Chris moves to not do a Fall Judge's Eval and re-evaluate after scheduling meeting to see about possible spring fundraiser, Rochelle seconds the motion. Passed with no opposition.

LINDA THORBERG CLINIC

- Linda Thorberg plan B needed since MAC will not be opening until Phase 3
- · Linda can do virtual clinic
 - Everyone agrees she is an effective presenter virtually
- Will be considerably cheaper to do virtually
 - Helpful in light of possibly no NAWGJ fundraiser

 - Sara has capacity for 100 people, cap attendance at first 99
 - Record for those who miss it
 - Fundraiser?
