

Oregon Judge's Information for Championship Meets

To be eligible to judge at championship meets, the USA Gymnastics State Committee has set forth the following selection criteria:

1. Rotate judges who have judged for 2 cycles with a National or Brevet rating into the 8/9/10 Regional meet.
 - a. One position at Level 7 Regionals can be assigned to a 1st cycle National judge at the committee's discretion. If there is not a judge at that rating available, then a judge from the 8/9/10 list will be rotated into that slot.
2. All Judges must be current with CPE, USAG and NAWGJ professional requirements, as well as be professional with coaches, gymnasts, meet directors, etc. and without complaints or concerns.
3. All judges need to have judged a minimum of 4 meets at the level they will be judging at the championship meets to be considered & put into the rotation schedule for the following year. {Exceptions to this rule can be made in instances of illness, etc., where a judge was assigned to a meet, but may not have been able to judge all or portions of the meet}.
4. A judge must have been available and chosen by the USA-gym committee for the previous year's Optional State meet to go into the rotation cycle for regionals.
5. Volunteer and participation in State & Regional positions and/or events will also be considered.

For the 2024 season, the Oregon championship meets are as follows:

March 16-17, 2024 – Compulsory State Championships, hosted by Westside, to be held at the Wingspan Event Center, Hillsboro, Oregon

March 22-24, 2024 – Optional State Championships and Xcel Invitational, hosted by The Athletic Edge, to be held at the Oregon State Fairgrounds, Salem, Oregon

April 6-7, 2024 – Xcel State Championships, hosted by Gymnastics Northwest, to be held at the Bob Keifer Center, Springfield, Oregon

April 12-14, 2024 – DP Regional Championships, to be held in Anchorage, Alaska

April 19-21, 2024 – Xcel Regional Championships, to be held in Boise, Idaho
