NAWGJ Oregon judges will evaluate an athlete's routine and will provide feedback as to the routine's start value including bonus, composition deductions, and major execution errors for optional/Xcel routines, and for compulsory routines, major execution deductions.

We are charging \$20 per all-around submitted or \$5 per routine if they are an event specialist.

We need your help to make this successful! You will need to have access to a laptop or iPad; we are working on a fillable form that you can save back to the google drive. If that doesn't work, we will have judges fill out the feedback form by hand and scan and save it to the google drive. Judging During the Pandemic - Safety First

Marian DeWane recent sent out USAG's policy on masks and competition. Here's an excerpt from their new policy:

USA Gymnastics Sanctioned Event Mandatory Face Coverings for All State and Regional Championship Events



"Effective immediately, USA Gymnastics requires that all participants and spectators wear a facial covering and maintain social distancing throughout the duration of any USA Gymnastics State/Regional Championship event. Facial coverings should be fitted or cone-style and consist of multiple layers of fabric. Bandanas, neck gaiters and masks with valves are not permitted. Meet directors should have disposable masks available for participants who arrive without the appropriate facial covering.

- During all competition and training sessions, coaches must wear a facial covering at all times, and maintain social distancing when not spotting.
- During competition and training sessions, athletes must wear facial coverings at all times outside of during the performance of gymnastics.
- All other participants, judges, event staff and spectators are required to wear a facial covering at all times and maintain social distancing protocols.

Please note, that failure to comply with the mandate may result in sanction revocation and/or event disqualification."

State laws still apply as well, so in Oregon, we will be masking up at all gatherings for the foreseeable future.
