# Oregon NAWGJ will be hosting a winter fundraising meet in December!



Thanks to the generosity of Peak Elite, we will once again host a judges feedback meet this December in order to replenish our finances for the coming year. We will hold the meet on Friday, Saturday and Sunday, December 6, 7 and 8, 2024. It will be a bit smaller meet than last year as we will only use one set of apparatus for competition.

Look for an email in the near future asking for your availability. Hotels are scarce in Corvallis and we will need to reserve rooms ASAP.

Our focus will be on Optional and Xcel athletes in order to give them feedback for the upcoming season; on Friday night, there will be a small compulsory meet for Peak Elite athletes only. We will reimburse judges for gas, pay for hotels, and feed you all weekend long. We will again have some exciting door prizes as well. Thank you all in advance for helping. We need all of you to make this meet a success!

### Meals will be reimbursable at Regional and National Congresses

Your NAWGJ board voted to add meals to the list of reimbursable items at Regional and National Congresses. Here are the specifics:

The total reimbursable amount will not change—\$1,100 for Regional Congress and \$1,300 for National Congress. You may claim up to \$60 per day for meals (excluding alcohol) for each travel day and each Congress day. Receipts for each meal MUST be submitted with your request for reimbursement.

If you are sharing expenses with another judge, you will need to break out the cost for each meal for each person.

As per the compensation plan that was previously shared, you will also be reimbursed for your hotel, gas money if you are driving, and flights.

If NAWGJ paid for your registration, please remember that the registration amount that has been paid is subtracted from your total reimbursable amount. If you participated in the group registration, NAWGJ paid \$125 for your regional congress registration and \$185 for your national congress registration.
