

PREVENTING COVID – 19 IN THE WORKPLACE: EMPLOYERS, EMPLOYEES AND FAMILIES WORKING TOGETHER



Across the world, businesses are taking extraordinary steps to prevent the spread of COVID – 19. For some workplaces, this may mean changing or limiting hours of operation, or closing for a period of time. Many employees have been told to stay home, others have been asked to work from home, while still others are asked to continue to go to work because their jobs are essential to keeping society functioning. This includes, but is not limited to, first responders, health care workers, critical infrastructure workers, grocery store and pharmaceutical workers and workers who are essential to supply society by critical goods such as food and medicine. As Alberta phases in a return to work plan for the Province, Childcare has been deemed essential to allowing the economy to reopen. While all employees should continue to practice physical distancing and hygiene in their personal lives, we also need to take additional measures here at Juvenescence to protect our employees, who are providing essential services. Employers and employees will need to work together to protect the health of employees, children, and families and to keep the workplace delivering its essential services. Parents will play an essential role in ensuring the safety of children and staff at Juvenescence by maintaining social distancing while at work and in the community and remaining within your family cohort to limit the spread.

All children and staff exhibiting the following **will be excluded until cleared by Alberta Health Services:**

- Fever of 38°C or higher
- New cough of any kind
- Shortness of breath
- Sore throat
- Runny Nose

Presentation of the following symptoms require you to stay home until symptoms resolve:

- Chills
- Painful swallowing
- Stuffy nose
- Headache
- Muscle or joint aches
- Feeling unwell, fatigue or exhaustion
- Gastrointestinal symptoms
- Loss of sense of smell or taste
- conjunctivitis

It is our policy to always follow mandated sanitization procedures to prevent the spread of communicable disease.

What is COVID – 19?

Novel coronavirus (COVID – 19) is a new virus strain spreading from person – to – person. It is currently in Canada and around the world. Most coronavirus illnesses are mild with fever and cough. The large majority of people with COVID – 19 do not require hospital care. Health experts are concerned because this new virus has the potential to cause severe illness and pneumonia in some people – especially people over age 60, people with underlying health conditions or weakened immune systems, and pregnant people.

Hours & Fees

- Hours 7:00am – 6:00pm (6:45 for Chaparral)
- Drop Off until 15 minutes **PRIOR TO BELL**
- Pick Up 30 minutes **AFTER THE BELL** or later

These measures are necessary to allow for proper cleaning and disinfecting of all surface's multiple times a day and to allow staff to safely support the transition to and from school. Staff will be unavailable to parents during this time.

Please Note: Fees will be payable and will not be refunded or prorated for any reason including non – attendance of children due to COVID or AHS short term closure related to contact tracing.

In the event that AHS deems an “outbreak” has occurred or Juvenescence staff cannot work due to COVID and Juvenescence is required to close for more than 72 hours, Juvenescence will discount the following months fees by 50% of the value of the closed period. The discount will be determined by the monthly fee, divided by the number of program days in the month to determine the per day value. The per day value will be divided by 2 and multiplied by the number of days Juvenescence is required to remain closed. This discount has no cash value, will not be refunded, and is only available to those families returning to care in the month following the closure.

Should Juvenescence be required to close for more than 72 hours, we will ensure the facility undergoes additional comprehensive cleaning procedures.

We have limited spaces for families and ask that once families register, they commit to the space whether they use it or not.

Drop in and part time care options are

currently available where space permits. Children using these options will count in the cohort limit of 30 and will always be in the same cohort to limit transmission of germs among groups of children.

Safety is a 3 – Way Street

Juvenescence Employees and Parents have an obligation to follow safety protocols as outlined by AHS to ensure their own safety but also the safety of those they encounter. If everyone does their part in maintaining social/physical distancing, staying home as much as possible, practice increased handwashing, sanitizing and cough/sneeze etiquette, we can work as a community to keep each other safe. Please refrain from bringing toys or other items from home until restrictions have been lifted.

Juvenescence as a company is committed to implementing practices that support the health and well-being of staff and children on the premises, providing appropriate PPE and supporting a clean and safe environment.

This Handbook is a living document and parents and staff should watch for updates to information that is guided by Alberta Health Services and the Ministry of Children's Services as we move into later Phases.

Let's all do our part to keep ourselves and those around us healthy and cared for.

Health Screening at Entry

- Parents should take their child's temperature before leaving home every morning. If your child has a temperature of 38°C or higher, notify the program and keep your child home.
- All staff must complete a Health Assessment before entering the building each day.
- Parents will be required to answer the same questions about travel, health and contact regarding the virus before children may enter the building.
- All staff and children are required to have their temperature taken prior to entering the building.
- All parents and staff are required to use the ABtracetogther App for early detection of contact with confirmed cases of COVID – 19.

Social Distancing

Juvenescence will reduce group sizes to no larger than 30 people total, including children and adults. We will keep groups together throughout the day, and will not combine groups (e.g., at opening and closing). To the degree possible, we will maintain the same groups from day to day. This will help reduce potential exposures and prevent our entire program from shutting down if exposure does occur.

Juvenescence is committed to the following protocol:

- Eliminate large group activities
- Limit the number of children in each program space
- Increase the distance between children during lunch and play.
- Limit item sharing, and if items are being shared, remind children not to touch their faces and wash their hands after using these items.
- Minimize time standing in lines.
- Incorporate additional outside time and open windows (where possible) frequently.
- Adjust the HVAC system to allow for more fresh air to enter the program space (where possible).
- Avoid gathering in larger groups for any reason.
- There will be no non-essential visitors or volunteers.

Outside Play

- Outdoor time will be in staggered shifts. If multiple groups are outside at the same time, they will have a minimum of 10 meters of open space between outdoor play areas or visit these areas in shifts so that they are not congregating. Park play is not permitted at this time.
- Outdoor toys and equipment will be

sanitized before each group plays outside. A playground attendant will be assigned to sanitize all outdoor toys and surfaces between groups. Handrails, toy bins, and locks must be disinfected after each use. Please check at the beginning of each shift that your First Aid backpack has sanitizer and paper towel for appropriate cleaning.

Meals & Snack Time

- Meals and snacks will be consumed with social distancing in mind, no combining of groups will be allowed.
- Children will bring snacks, water bottle and lunch from home that does not require heating and in containers that children can open/close independently.
- Should a staff need to help children with food, gloved hands will be used and then gloves will be disposed.

Drop – Off & Pick - Up

- We will not combine groups in the morning or afternoon.
- Parents need to call the centre when arriving to stagger parents dropping off/picking up children.
- Staff will ask the health screening questions before parents can drop their child off.
- Parents will not be allowed in the centre.
- Children will wash their hands before joining their playroom for the day.
- Staff will be responsible for child sign in/out to prevent the spread of germs.
- Staff will wipe down all touched surfaces before allowing the next person to enter.
- A daily record will be kept of anyone entering the facility for 15 minutes or longer.
- Sanitizer will be in the entrance for all adults entering the building but will be kept out of reach of children. Children are not recommended to use hand sanitizer and will instead wash hands frequently.

For All Employees

- All employees should ensure they understand and comply with the infection prevention policies and practices in place at Juvenescence.
- Wash your hands often with soap and water for a least 30 seconds.
- If soap and water are not available, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose, and mouth.
- Cough or sneeze into the bend of your arm.
- Avoid touching surfaces people touch often.
- Instead of a handshake, give a friendly wave or elbow bump.
- Use any necessary personal protective equipment as provided. Keep your environment clean.
- Use appropriate products to clean and disinfect items within your group space, work surfaces, shelves, toys, chairs and tables, doorknobs, windows more often, especially when visibly dirty.
- Each staff will need indoor shoes that are disinfected at the end of each day.
- Maintain accelerated hygiene practices such as daily showers, changing clothing and shoes when arriving at work and home.
- Keep 2 meters between you and your coworkers, and parents.
- Increase distance between you and co-teachers. Consider rearranging the space to create marked areas for social distancing.
- Limit any contact closer than 2 meters to the shortest time possible.
- If you have a symptom of COVID – 19 (see COVID Symptoms) or if you think you have COVID – 19, use the Alberta Self-Assessment Tool to find out what to do. <https://myhealth.alberta.ca/Journey/COVID-19/Pages/COVID-Self-Assessment.aspx>
- It is critical that if you have one symptom of COVID – 19, or even mild symptoms, you should stay home to avoid spreading illness to others. Contact your Supervisor immediately to discuss.
- If you develop even mild symptoms while at work, separate yourself from others and go

home, avoid use of public transit if possible.

- Follow the advice of the Assessment Tool when it comes to tracking and assessment.

Children, Staff or Parents who Develop COVID – 19 or Symptoms

- Children or staff with a fever (38°C or higher), cough or shortness of breath will be excluded from the centre. Children with household members who are known to have COVID – 19 will also be excluded from the program for 14 days or until return is approved by Alberta Health Services.
- If a child develops symptoms of COVID – 19 (see Symptoms of COVID – 19) while at the centre, staff will immediately separate the child from other children until the ill child can leave the centre.
- Parents will be expected to pick up the child immediately, within 45 minutes.
- If symptoms persist or worsen, you should call 8-1-1 for further guidance. Please report to the centre management team immediately if your child is diagnosed with COVID – 19.
- Items touched by the child will be immediately sanitized upon departure.
- Staff should wear appropriate PPE when interacting with a child who is ill. This includes gloves and a mask.
- If a child tests positive for COVID – 19, you should contact the AHS to identify the close contacts who will need to quarantine. It is likely that all members of the infected child's classroom would be considered close contacts.
- If Juvenescence is notified of a confirmed or probable case of COVID – 19 among our staff, parents or children, we will consult Alberta Health Services and follow their direction in ensuring safety of all participants which could include, but is not limited to temporary closure or increased cleaning protocols.
- A 72-hour minimum closure will occur if a case of COVID – 19 develops to allow time for AHS to contact trace and limit the spread.
- Any illness (not COVID – 19) will require the child to be excluded from the program until they are symptom free for 24 hours.

If you have symptoms of or have been diagnosed

**with COVID – 19, use the Self –
Assessment Tool and wait for
instruction from Alberta Health
Services regarding testing.**

Travel for Staff & Families

- Non – essential travel should not occur at this time.
- Consider the risks and benefits related to any upcoming travel and evaluate other options, such as postponing, cancelling, or participating virtually.
- Check the latest information on affected areas and travel health notices.
- When you return from any travel outside Canada, you must self – isolate for 14 days before returning to work or childcare.
- Staff who choose to travel outside of Canada can use vacation or personal time during your isolation period; however, this is an unpaid decision to travel.
- When you return from travel monitor yourself for symptoms, such as a cough, fever or difficulty breathing for 14 days. If you develop even mild symptoms, contact AHS through the Self – Assessment Tool and wait on further instructions.
- If during your isolation period you develop symptoms, remain in isolation for an additional 10 days or until symptoms resolve whichever occurs later before returning to work or care.

Centre Signage

Staff will ensure that reminders are posted at the entrance and by sinks with reminders of:

- Checking your temperature each day.
- Practicing hand hygiene, and cough/sneeze etiquette.
- Do not enter if sick.
- Help prevent the spread posters
- Use a cleaning agent to wipe all surfaces and follow up with a disinfectant or approved bleach solution.
- A high touch surface checklist for cleaning and disinfecting that must be completed at 2 times/day.
- All toys played with will go into a

Cleaning Practices

- receptacle after use and will be disinfected before being used again.
- Items not easily sanitized will be removed from the centre.
- Each child will have a separate bin for art supplies that will not be shared with others.
- Empty garbage and recycle bins frequently to prevent materials with body fluid from remaining in the building.

Symptoms of COVID - 19

All children and staff exhibiting the following ***will be excluded:***

- Fever of 38°C or higher
- New cough of any kind
- Shortness of breath
- Sore throat
- Runny Nose

Presentation of the following symptoms require you to stay home until symptoms resolve:

- Chills
- Painful swallowing
- Stuffy nose
- Headache
- Muscle or joint aches
- Feeling unwell, fatigue or exhaustion
- Gastrointestinal symptoms
- Loss of sense of smell or taste
- Conjunctivitis

2. _____ I understand that my temperature will be taken every day before I enter the building.
3. _____ I understand that the facility has adopted enhanced cleaning procedures and I will comply with and complete all cleaning and disinfecting tasks as assigned each day.
4. _____ I will wash my hands using AHS recommended handwashing procedures throughout the day using warm running water and rubbing with soap for at least 30 seconds.
5. _____ I understand that I must bring a pair of shoes to the facility that will ONLY be worn inside this facility and will be left here each evening. I MUST remove the shoes I wear coming to work at the entrance of the facility, change into my work only shoes, place my outside shoes in the designated area and wash my hands immediately.

6. _____ I understand that I must bring a separate change of clothes to the facility that will ONLY be worn inside this facility. I MUST wash my hands before I change into my work only clothes.
7. _____ I understand that outside of work, in order to control my exposure in the community, I will comply with any and all Provincial, City or local stay-at-home orders, and will follow any recommendations from AHS that limits my risk for exposure including wearing a mask in all public areas and remaining 2 meters from all other people.
8. _____ I will immediately notify JUVENESCENCE CHILD DEVELOPMENT CENTRE LTD. management if I become aware of any person with whom I have had contact exhibits any of the symptoms listed in Number 1 above, is advised to self-isolate, quarantine, or has tested positive, or is presumed positive for COVID-19.

Please read and initial each statement below.

1. _____ I understand that during this COVID-19 Public Health Emergency I will NOT be permitted to enter the facility beyond the designated drop-off and pick-up area. I understand that this procedure change is for the safety of all persons present in the facility and to limit to the extent possible everyone's risk of exposure. I understand that it is my responsibility to inform any Emergency Contact persons of the information contained herein.
2. _____ I understand that IF there is an emergency requiring me to enter the facility beyond the designated drop-off and pick-up area I MUST wash my hands before entering, remove my shoes and wear a mask. While in the facility I must practice social distancing and remain 2 meters from all other people, except for my own child.
3. _____ I understand that to enter upon the facility premises my child must be free from COVID-19 symptoms. If, during the day, any of the following symptoms appear my child will be separated from the rest of the people in the center. I will be contacted, and my child MUST be pick-ed up from the facility within 45 minutes of being notified.

Symptoms include,

- Fever of 38° Celsius or higher
- Dry cough
- Shortness of Breath
- Sore Throat
- Runny Nose
- Nasal Congestion
- Chills
- Unexplained loss of appetite
- Fatigued
- Nausea/Vomiting/Diarrhea
- Muscle aches
- Headache
- Conjunctivitis
- Painful swallowing
- Loss of sense of taste or smell

While we understand that many of these symptoms can also be related to non-COVID-19 related issues we must proceed with an abundance of caution during this Public Health Emergency. These symptoms typically appear 2-7 days after being infected so please take them seriously. Your child will need to be symptom free without any medications for 72 hours before returning to the facility.

4. _____ I understand that my child's temperature will be taken every day before entering the facility.

5. _____ I understand that my child will be required to wash their hands using AHS recommended handwashing procedures throughout the day using warm running water and rubbing with soap for at least 30 seconds.
6. _____ I understand that I must bring my child a pair of shoes to the facility that will ONLY be worn inside this facility and will be left here each evening. My child MUST remove their shoes at the entrance of the facility. Staff will have the child put on their “center only shoes” once the child washes their hands and goes into the classroom. At pick up, the child will remove their “center only shoes” and the child will be brought to the entrance where they will put on their outside shoes prior to leaving the facility.
7. _____ I understand that outside of care, in order to control my child’s exposure in the community, I will comply with any and all provincial, city or local stay-at-home orders, and will follow any recommendations from AHS that limits my child’s risk for exposure including wearing a mask in all public areas and remaining 2 meters from all other people.
8. _____ I will immediately notify JUVENESCENCE CHILD DEVELOPMENT CENTRE LTD. management if I become aware of any person with whom my child or I have had contact exhibits any of the symptoms listed in Number 3 above, is advised to self-isolate, quarantine, or has tested positive, or is presumed positive for COVID-19. Further, I will immediately notify JUVENESCENCE CHILD DEVELOPMENT CENTRE LTD. management if anyone from my place of employment is presumed positive or tests positive for COVID-19 whether or not I have had direct contact with that person.
