### Contract and Fee Agreement 2021/2022

#### **General Agreements:**

The monthly fee will be due and payable the <u>1st of the month</u> by the Pre-Authorized Debit or Cheque. Fees are payable regardless of attendance.

- 1. <u>Siblings Discounts.</u> Families with 3 or more children attending Juvenescence are eligible for a 10% discount applied to the 3rd and subsequent child's fees. (Initial if applicable)
- <u>Teacher Discount</u>. Parent/Guardian understands that 5% discount is only for a parent/guardian that teaches in a school that Juvenescence services. Limited spaces available at the centre for families who receive this discount. (Initial if applicable)
- Late Fees \$10.00 for the first 10 minutes or any portion thereof and \$1.00/minute for each additional minute for picking up children after program closes. Late fees are per child and are payable to the program staff upon child pick up. (initial here)
- 4. <u>Returned Payments:</u> Returned payments will result in a charge of \$50.00. Cash payment of fees may be required if return fees are recurring or habitual. (initial here)
- 5. <u>Term:</u> The child is enrolled in Juvenescence and fees payable for the current school year. Annual re-enrollment happens in April every year. Should your child care needs change, a full calendar months notice is required.
- 6. Child Attendance: Notice is required any time your child will be absent from Juvenescence. (initial here)
- 7. <u>No Call Charge:</u> When a child does not arrive to the program after school, they are considered a missing child. If the child cannot be located quickly by calling the parents, Juvenescence notifies the Calgary Police Authority and the Calgary Licensing Authority. If police need to be contacted and parents have the child, a \$75.00 will be incurred by the family. (initial here)
- 8. <u>Tax Receipt:</u> Payments for 2021/2022 school year which parents name should the tax receipt be issued to?

9. <u>Excuse of Performance</u>: If Juvenescence Child Development Centre Ltd is delayed, or hindered in or prevented from the performance of any tern, covenant or act required by this agreement by reason of any cause beyond it's control, without limitation, strike, lockout or other labour disputes, the enactment, amendment, directive, policy, order by any governmental or quasi governmental authority or repeal of any laws, shortages or unavailability of labour or materials, riots, insurrection, sabotage, rebellion, war, acts of terrorism, act of God, weather, pandemics, or any other similar reason (an "Event of Force Majeure"), then performance of such term, covenant or act is excused for the period of the delay. However, an Event of Force Majeure shall not excuse or release the Parent/Guardian from the prompt payment of the fees in the amounts and at the times specified in the Agreement. (initial here)

13. <u>1<sup>st</sup> Month Fee:</u> Upon registration, the 1<sup>st</sup> month fee are due and payable. This fee will be cashed upon acceptance into the program and applied to the first month of care. Should your childcare needs change before care begins, the 1st month's fees will be refunded provided 1 month's calendar notice has been provided using the Child Care Withdrawal Notice Form.

#### ANNUAL RE-ENROLLMENT FEES: (existing families)

- 1. In this Authorization "we", "us' and "our" refer to the Payor(s) indicated on the form hereof.
- This Authorization is provided for the benefit of 2. Juvenescence Child Development Centre Ltd. and our Financial Institution and is provided in consideration of our Financial Institution agreeing to process debits against our Account in accordance with the rules of the Canadian Payments Association. We agree that any direction we may provide to draw a PAD, and any PAD drawn in accordance with this Authorization, shall be binding on us as if signed by us.
- 3. We acknowledge that the amounts to be drawn against our account may vary in accordance with the amounts billed by Juvenescence Child Development Centre Ltd. and we authorize Juvenescence Child Development Centre Ltd. and our Financial Institution to process PADs against our Account and to draw all such amounts without any pre-notice to us or any other consent by us.
- We acknowledge that, while Juvenescence Child 4. Development Centre Ltd. will normally draw PADs against our Account 4 days after it renders its account billing, the dates on which Juvenescence Child Development Centre Ltd. will draw PADs against our Account my vary from time to time in accordance with Juvenescence Child Development Centre Ltd.'s normal billing and processing 7. procedures, and we authorize Juvenescence Child Development Centre Ltd. to draw PADs and our Financial Institution to process such PADs on different dates of the month from time to time without any pre-notice to us or any other consent by us. Further, in the event that any PAD is not honoured, due to "NSF" or other reasons other than our revocation of this Authorization or noncompliance of the PAD with this Authorization, we authorize Juvenescence Child Development 8. Centre Ltd. to re-submit the PAD within 30 days of the date of dishonour and our Financial Institution to process such PAD without any pre-notice to us or any other consent by us. We acknowledge that a NSF transaction fee of \$50.00 will be charged for each NSF transaction and will be added to the resubmitted PAD.
- We certify that all information provided with respect to our Account is accurate and we agree to inform Juvenescence Child Development Centre Ltd, in writing, of any change in the Account information provided in this Authorization prior to the next Juvenescence Child Development Centre Ltd. billing date. In the event of any such change, this Authorization shall continue in respect of any new Account and Financial Institution to the same extent as if they had been shown on the signed form. We guarantee that the signatories to any written notice of change we provide to Juvenescence Child Development Centre Ltd. Will be all such persons as would be required to sign any cheque drawn on or withdrawal made from the new 9 Account.
- We agree that our Financial Institution is not required to verify that any PAD has been drawn in accordance with this Authorization, including the 10. amount, frequency and fulfillment of any purpose to which the PAD relates. We agree that delivery of this Authorization to Juvenescence Child Development Centre Ltd. constitutes delivery by us to our Financial Institution, and that Juvenescence Child Development Centre Ltd. may deliver a copy of this Authorization to Juvenescence Child Development Centre Ltd 's Financial Institution for the purpose or processing PADs, and we consent to the disclosure of any information contained in this Authorization to such Financial Institution
- We may revoke this Authorization at any time either orally or by delivering written notice of revocation to Juvenescence Child Development Centre Ltd. This Authorization applies only to the method of payment, and we agree that revocation of this Authorization does not terminate or vary in any way any contract or terms of service under which services are provided to us by Juvenescence Child Development Centre Ltd.
- We may dispute a PAD drawn on our Account where: (i) the PAD was not drawn in accordance with this Authorization, or (ii) this Authorization was revoked by us. In order to obtain reimbursement by our Financial Institution for a disputed PAD, we

must sign the required form of declaration and deliver it to our Financial Institution in accordance with rule H1 of the Canadian Payments Association. In the case of "personal" PADs as defined in rule H1, which includes PADs for residential accounts, the specified period of 90 calendar days after the date on which the disputed PAD was drawn on our Account. We acknowledge that if notice is not given in accordance with rule H1 within these specified periods, any dispute regarding PAD must be resolved solely with Juvenescence Child Development Centre Ltd. and that our
