# **Secretary's Report**

DEVNO Board of Director's Meeting Minutes from October 16, 2025

Meeting was called to order by President Bob Knudsen, via phone, at 4:00 p.m. at the Waterford Sports Club.

Board members present were Gail Haynes, Janet Wonderlie -Cook, Todd Gilbreath, Michael Horvath. Also present via phone were: Bob Knudsen and Anthony DiGiovanni. Excused was Tom Lechmanik.

Member of DEVNO present were: Pam Harvey, Moni Dusablon, Melissa Stofko, Jan Taft, Tom Taft, Rob Zoz, and Barb Calder.

#### **New Business:**

- Jan moved, seconded by Gail that we adopt the Email policy presented by Bob and included with the meeting agenda. After discussion, Todd Gilbreath abstained and 5 ayes, no nays, the motion passed.
- Items 2 and 3 on the agenda: Bob moved, Janet seconded that these items be tabled for future consideration. All agreed.
- Bob reminded everyone that there are currently 3 board positions available to be filled at the Annual Election.
- Todd requested that there be some discussion on the new Email policy. After some clarifications by the board and members present, it was agreed that items regarding social events or information about extreme weather, should be considered as informational and not actions of the board.

# **WMOA ARC Report**

November 4,2025 Meeting

Property manager reported there were 19 variances submitted, two were withdrawn 190 violations from the monthly inspections:

- 111 closed
- 49 remain
- 19 on hold (what about the others)

Sixty violations over all remain outstanding, no hearings to be held in November. The WMOA communication/educational report for November will be on Yard Lights

The ARC committee has been asked by President Pam Shierberg to review ARC rules and where there is a provision in the CCR's relating to that rule, write specifications for clarification and the rule will then be removed.

The topic of Iguanas was presented. There is a presence in Waterford. A few facts about the invasive reptile and the legal way to deal with them.

- Do not confuse their hole with that of an armadillo, the Iguana dig a sideways D shaped hole, and, in most cases, their tail marks can be seen leading into the hole.
- You will most likely see these in March through May when the female lays her clutch of 20 to 70 eggs.
- Armadillo digs a half mood shape hole and may occur any month. Both prefer loose sandy areas. The Iguana likes the banks of lakes and ponds thus the concern for our "Enforced lake banks".
- Iguanas have been around for 10,000 years, are a source of low fat protein and are often used in tacos and burritos in the islands. They are known as "the chicken of the trees".
- They are most active in the evening hours, hide in trees, not direct sunlight areas.
- In Sarasota County you can trap or shoot them with a pellet gun. If you choose to trap, you then call the Animal control at 914-861-9500 for pick up. This will cost you \$50.00 per reptile, if you shoot them, double bag and put into your trash.
- An additional concern is the fact that their feces carries salmonella which can be harmful to your pets and other animals.

## WMOA BOARD OF DIRECTORS MEETING

The board has approved the Reclassify the following Reserve Accounts to Deferred Maintenance: Road Sealing, Fountains, Gates, Sports Club Paver Sealing, Drainage Structures, Mailboxes, Lights, Park Benches, and Lake Bank Maintenance.

- 2026 Reserve Budget was approved in the amount of \$242,842.08
- 2026 Operational Expenses Budget was approved in the amount of \$1,277.279.00
- 2026 Annual Assessment with an increase of 3.1% was approved.
- The Annual HOA payment will be \$2,232.00
- The 2026 fee schedule will remain the same.

A report was given regarding seal coating our roads by the gentleman whose company is paving our roads. We are on a 15-year replacement plan which requires no seal coating according to the presenter. Our best option is to continue to remove and inch to an inch and a half and repave every fifteen years. He explained that the cracks are due to the high-water table found throughout Florida and sealcoating will not resolve that issue.

Tom Galek was appointed to the nominating committee.

Denise Rogan's resignation from the ARC committee was approved.

The revised CCR's are in the process of being changed by the attorney. When that is done, the board will sign off, and we will be able to have a copy of the revisions.

The project status reports were given:

The muti-purpose area will hopefully be finished by Christmas. There are several items remaining. Root barriers around several Grand Oaks (I encourage you to check this out regarding the success of doing this on a mature oak, consult Google), the basketball hoop, hard and soft landscape, telescoping poles, signage, and the city permit release.

Tennis courts will be addressed in May to minimize interruption during the season.

A report highlighting the Venice Sarasota Memorial Hospital was given. The hospital celebrated its fourth-year anniversary this week. The facility is 90% occupied the majority of the time. The new building is for the radiology department that is adding additional MRI's and the addition of fifty rehab beds plus additional general care beds. There is a desperate need to update their IP format to improve communications and records between hospitals and doctors' offices. North Port does not have a hospital and with 85% of its population being over 55 years old, efforts are ongoing by Sarasota Memorial of Venice to resolve this matter.
