### What is the RASCC Legacy Fellowship Grant?

The **RASCC Legacy Fellowship** provides support to one or more creative member(s) of the college community who proposes a project or activity, not currently provided by the College, that will enhance the educational experiences of Suffolk County Community College students.

### What is the Fellowship Award Amount?

The RASCC Legacy Fellowship provides an award of up to \$1,000.

### Am I Eligible?

All active members of the college community are encouraged to apply for the **RASCC Legacy Fellowship Grant**. This includes administrators, faculty, office personnel and all college employees. No one is excluded from applying.

## RASCC Legacy Fellowship Grant Application Requirements.

Applicants must submit a proposal to the RASCC Legacy Fellowship Committee stating the following:

- ☐ Must be a new project or activity in the college community.
- ☐ Must be implemented and completed in one academic year.
- ☐ State clearly who will administer and be responsible for the success of the project or activity.
- ☐ Clearly state the objectives and the actions to be taken to accomplish these objectives.
- ☐ Identify those colleagues who will be involved in implementing this project or activity.
- ☐ Detail where and when the project or activity will take place.
- ☐ Detail how this project or activity will be evaluated.
- ☐ Submit a budget that describes how the funding will be used.
- ☐ Submit a mid-term progress report to the RASCC Legacy Fellowship Committee.
- ☐ Submit a final report at the conclusion of the project or activity stating which objectives were obtained, as well as which objectives were not met and why.
- ☐ Submit a Letter of Support from your Campus Executive Dean.

### What is RASCC?
