LEWIS COUNTY CEMETERY DISTRICT #6 ALPHA, ETHEL, AND SHOESTRING CEMETERIES

- 1. Lewis County Cemetery District #6 reserves the right to make and/or change rules and regulations concerning any interest relating to said district.
- 2. All lots sold within the boundary of the cemetery shall be used for no other purpose than the interment of the Human Remains or Human Cremated Remains.
- 3. All interments must be made under the direction of the Secretary who will have entire control of all matters relating to burials.
- 4. No disinterment shall be permitted except in accordance with the law.
- 5. No plot(s) shall be considered as sold until the payment hereof shall have been fully made. No payments accepted on pre-need plots. No headstones shall be allowed to be set until plot is paid in full.
- 6. All interments in plots for which purchase of burial rights have been issued shall be restricted to the members of the family and relatives of the owners except by special permission to be obtained in writing from the Commissioners and the Secretary of the cemetery.
- 7. The owners of plots and their families and friends shall be allowed access to the grounds observing the rules and regulations of the cemetery.
- 8. The cemetery district must be notified of intent of burial in order to be marked correctly.
- 9. The arrangement of any transferral by sale or gift must be approved by the secretary or commissioners.
- 10. Parents or guardians shall be held responsible for the conduct of children under age of 18 while on cemetery ground.
- 11. Any person driving in the cemetery shall be responsible for any damage done. Heavy loads will not be allowed to enter the grounds without permission by a commissioner or secretary.
- 12. The throwing of rubbish on any part of the cemetery grounds is strictly prohibited.
- 13. No horses or dogs (except Seeing Eye dogs) allowed on cemetery grounds.
- 14. No firearms allowed on cemetery grounds except by Military personnel.
- 15. No alcohol or drugs permitted on cemetery grounds.
- 16. No use of boisterous or profane language or action permitted that would in any way disturb the quiet and good order of the cemetery.
- 17. All improvements and ornaments made and work done on any plot must be subject to permission of the Commissioners and/or the Caretaker.
- 18. The Caretaker shall establish the grade of all plots, lawns and roads and shall direct generally all improvements within the grounds upon all plots before as well as after interments have been made therein and no lot shall be filled or raised above the established grade. He will have charge of the planting, sodding, surveying and general improvements of the cemeteries.
- 19. No artificial flowers or plants permitted April 1st Nov 1st.
- 20. No permanent planting in cemeteries.
- 21. A limit of one Human Remains and one cremation interred or 3 cremations in each plot.
- 22. All Human Remains must have an approved outer burial container.
- 23. No setting of head stones (monuments) by unauthorized parties. Cemetery District must be notified prior to the setting of any stone or marker.
- 24. One raised stone per grave. Any additional stones must be flat level with grade). A limit of three (3) stones or markers per grave.
- 25. All stones must have a minimum 4inch concrete border surrounding the stone or marker with overall measurements not to exceed 24 inches by 48 inches including vase.
- 26. If any monument, structure effigy, inscription or placard in or upon the plots shall be regarded as improper, offensive or injurious to surrounding lots or people, caretaker shall remove the same.
- 27. All pots, planters, ornaments, etc. should be removed as their appearance declines
