DIRECTIONS TO Lake Murray Training Center (From I-20)

1. From I-20 West of Columbia, SC Take exit 61 toward Lexington, 0.4 mi
2. Merge onto US-378, 0.1 mi
3. Take Corley Mill Rd/State Rd S-32-68 to your destination, 10 min (5.9 mi)
4. Slight right toward Corley Mill Rd/State Rd S-32-68, 180 ft
5. Slight right onto Corley Mill Rd/State Rd S-32-68, 4.9 mi
6. Turn right onto SC-6 W, 0.5 mi
7. Turn right, 0.1 mi (reference yellow dashed for main entrance)
8. Turn left, Destination will be on the right
