

Digital Music Track Publishing Agreement

between

Digital Media Group SoundScribe Publishing T. K. Fritsche Seecktstr. 7c 13581 Berlin, Germany (hereinafter referred to as "Publisher")

and

(hereinafter referred to as "Artist")

- §1 Subject Matter of the Agreement
- 1. The Artist commissions the Publisher to release their musical works in digital form worldwide via a distributor of their choice.
- 2. At the Artist's request, the Publisher will also commission the design and provision of the artwork for the release.
- 3. The Publisher acts solely as a publishing and distribution service provider.
- § 2 Fees
- 1. The publisher receives a fixed fee for its services:

€29.99 per single (track)

€99.99 per album (maximum 10 tracks)

- 2. Payment is due upon placement of the order for the distribution and release package in the SMP (StRANGe Music Productions) online shop.
- § 3 Copyright and Rights
- 1. The copyright to the digital music works remains fully with the artist.
- 2. The publisher receives a simple, non-exclusive right of use, solely for the publication, distribution, and promotion of the tracks via the distributor.

3. Any other use, modification, or commercial exploitation requires the artist's written consent.

§ 4 Artist's Obligations

- 1. The artist warrants that they are the holder of all rights to the music works and that they do not infringe upon the rights of any third party.
- 2. The artist will provide the publisher with the digital tracks in release-ready quality, along with the necessary artwork (digital cover, lyrics, etc.).
- 3. The artist will indemnify the publisher against any third-party claims arising from the infringement of copyright or personality rights.
- 4. The artist is solely responsible for registering the digital tracks with a collecting society (GEMA, PRS for Music, ASCAP, etc.), collecting royalties, and licensing them for radio, streaming, television, film, and advertising. The artist expressly releases the publisher from these obligations.

§5 Publisher's Obligations

- 1. The publisher will release the digital music works carefully and promptly through the selected distributor.
- 2. The publisher will ensure the correct presentation of the artist, their name, title, and artwork.
- 3. The publisher will inform the artist of the successful release.

§6 Contract Term and Termination

- 1. This contract enters into force upon signature.
- 2. The contract terminates automatically upon release of the digital tracks and full payment of the agreed-upon fees for the released digital tracks.
- 3. Termination for cause is possible at any time, in writing, stating the reasons.

§ 7 Miscellaneous

- 1. Amendments and additions to this contract must be in writing.
- 2. Should any provision of this contract be invalid, the remainder of the contract shall remain in full force and effect.
- 3. Applicable law: Germany
- 4. Place of jurisdiction: Berlin, Germany
