Pizzazz Dance Center Safety Procedures and Policies Updated: 7/12/2020

- 1. Student drop off of will be at a designated time. Students will wait outside of the studio entrance in a socially distanced manner. A staff member will allow students to come in to the lobby at the scheduled class time.
- 2. Students will have their temperature checked with a no contact Infrared thermometer and students will use hand sanitizer from a no contact dispenser while entering the premises.
- 3. Students must arrive in their dance attire. Changing and dressing will not be allowed in the restroom.
- 4. The waiting room is closed until further notice except for dancers attending class. No parents, siblings, or guests are permitted in to the waiting room before, during, or after class.
- 5. Students will sit in their designated chair, change shoes, and leave all belongings on the top of their designated chair. Students will enter the dance room and go to their assigned spot.
- 6. Students will spend the majority of their class in socially distant spacing but will enjoy other areas of the room such as the ballet barre and movements across the room.
- 7. At the end of class, students will leave the dance room and go to their designated chair. Students will change their shoes, gather up their belongings, and then exit the building.
- 8. Enhanced cleaning measures have been set. Restrooms, dance rooms, etc. will be cleaned in between classes. Dancers will not be allowed to stay at the studio, **please be prompt for pickup**.
- 9. Students cannot be late, as there won't be any extra staff members at the studio to let them in the building.
- 10. Students should use the restroom before they arrive at the studio. We would like to cut down on the amount of students using the bathroom.
- 11. <u>It is mandatory by our state government that all students and staff members wear a mask during the entire length</u> <u>of the class.</u> Students will not be permitted in the building without a mask unless by a doctor's request.
- 12. Payments will now need to be made online through our parent portal. If you would rather pay by check or cash please make sure that your child has payment while entering the studio. Cash must be exact.

- 14. Twinkle Stars I, Twinkle Stars II, and Garnet Level families... ONE female parent/guardian will be allowed in the building in case bathroom breaks are needed. Every week a different female parent/guardian will be assigned to take that job! This does not mean that <u>each</u> child can have one parent/guardian in the lobby. This means that just <u>ONE</u> parent/guardian will be allowed in the lobby area with a mask on.
- 15. Twinkle Baby & Me families... one parent or guardian is permitted to attend class with their dancer. This means that <u>every child</u> enrolled in Twinkle Baby & me can have one parent or guardian with them, no siblings are permitted because our capacity is very limited.
- 16. All of our classes will be hybrid, meaning that students can take class at home! If you are unable to return to in-person classes or prefer to take class without a mask then you may take class through a live Zoom feed.
- 17. If your child is taking class in-person then parents may watch class through the Zoom feed.
- 18. There will be no contact between dancers at any time.
- 19. There will be no eating in the studio. Students may not bring food or snacks into the premises.
- 20. Our store will be open by appointment only, remember to shop small! Please plan ahead and check your dancer's shoes and apparel early.
- 21. Thank you for cooperating as we will work very hard to make our classes fun in this still uncertain time.
- 22. Thank you so much for enrolling your child!!!
