3.0 Committee Reports

- A. **Frequency Study Committee** – We are currently working with MIARC and UNYREPCO, along with input from OARC and WPRC to formulate an agreement involving all the adjacent councils to come up with a bandplan for utilizing the D-STAR format for repeaters. MIARC and UNYREPCO have already forwarded suggestions and recommendations for which frequencies and separations they feel will work best.

WNYSORC will be working with the coordinators of the adjacent councils to assist in coming to an agreement that will work for all. At this time there are many proposals being considered for both VHF and UHF bands, and noting is anywhere near being finalized. This is a “work in progress” and is much too important to be rushed.

WNYSORC is not going to just implement any type of bandplan without input and agreement with the adjacent councils, in case what we deem possible may be in total conflict with what the rest of the amateur community has selected as a standard.

If not on the air within 30 days the assignment will be cancelled. Also coordination for 224.580 since 3-12-05. If not on the air within 30 days the assignment will be cancelled. 53.150 is defunct. 224.580 – has been on the air intermittently. Should be on the air by July 1, 2007.

IC-2006-001	W2DXA – 147.390 – station is experiencing co-channel interference by an uncoordinated repeater run by the Portuguese ARC on the same frequency within the 100 mile limit.	Since WNYSORC is not a regulatory body we have advised W2DXA to file a complaint with both the FCC and IC should the problem not be resolved amicably. Resolved. PARC moved from the frequency.
IC-2006-002	VE3WAS – 146.610 – station is being interfered with by an uncoordinated repeater on 146.620 operated by VE3TVG. 146.620 is not a standard repeater frequency.	Since WNYSORC is not a regulatory body we have advised VE3WAS to file a complaint with IC should the problem not be resolved amicably. Status unknown
