

## WNYSORC minutes April 21, 2002

Old Minutes- Okayed by va3nz, seconded by -wb2dss

In regards to the repeater pair requested for uhf on 444.725 or 444.625 there is no contact person with the callsign given "va3zh"? Ask Ve3nsl who lives in Orangeville in regards to this if he knows who the person is. Bruce Weber ve3acl is also a resident who might have knowledge of this repeater?

Ve3ayr and va3pt to be sent a notification that WNYSORC freq. are copyright.(see front of ARRL directory for format of legal jargon for repeater information.) These gentlemen have agreed in principal to work with the council in the publication of their directories and try to support the council by adding some kind of acknowledgement to the repeaters that are coordinated. This will also entice repeater owners to join the council and work together cooperatively.

147.270 Erie is IRLP node and was requested it be added to the list for the website under the heading IRLP Nodes as general information to amateurs.

Notice of motion - Give Ben free hand to change county names to regional metropolis areas. Names concerned to county lines? Needs to outline exact borders to be defined as in the e-mail "Nb-C". Notifications to be sent and voted on next meeting to finalize movement and trade of areas between UNREPCO and WNYSORC.

Suggestions from the floor:

(need letter of intent form UNYREPCO grandfather all repeaters into their group.)

Jim ve3ja suggests registered mail and reasonable response time such as 30 days from delivery. (failure to reply agrees to motion) There are only seven repeater owners effected by this move so the seven will be given notification in writing and a chance to respond accordingly. All matters will be handled individually on merit and hopefully the swap will go through to simplify the geographic areas involved. This will eliminate the confusing line along the Genesee River. Motion - WB2DSS second by N2NYM.

In response to WA1ZLC atv repeater request. - WNYSORC does not coordinate cross band repeaters. Send letter in regards to this oddball pair. Give suggestions as to alternative freq possibilities such as 1.2 gig. And return the ten dollars to the group that was sent in by them requesting coordination.

"Nb-E" regarding simplex IRLP – send letter stating we don't coordinate this. Try to use a freq in the simplex spectrum.
