- A. Frequency Study Committee – Research has been done to find out what other councils have done to accommodate digital machines. Proposal in the works to change spacings is being considered. Our area has at least one example of replacement of analog with digital on regular frequencies. Moved to accept, VA3KRA, seconded, N2OBW, carried
- B. Technical Committee – Andy Mill KD2ZWA reported his feelings that co-channel D-Star should be allocated on splinter channels rather than on analog channels, thus freeing analog frequencies. He noted that other councils have not followed this practice but that the WNYSORC area is congested enough that his proposal makes sense for us and represents a chance for forward momentum.
