Annual Meeting Recap

Our annual meeting was held on February 17th at Lakeside United Methodist Church. The business of April Cove was discussed. These are a few highlights of votes that were taken.

- -Two projects were proposed to be added to the 2019 budget. The first was to install an April Cove Mail box in the neighborhood. The new address for all April Cove mailings will be 113 April Cove, Streetman TX 75859. The second was was to purchase two flag poles for the front entrance to display an American flag and a Texas flag. Members voted in favor of the budget additions.
- -Motion was made to raise the Annual Dues by \$35 per lot to cover a projected future budget deficit. Motion passed and will take effect in January of 2020.
- -Motion was made to move the Annual Meeting from the 2nd Sunday in February to the 2nd Saturday in February to make it easier for "weekenders" to attend the meeting. Motion passed.
- -Two deed restrictions changes we proposed. The first was to allow cattle on lots larger than 10 acres and the second was to increase the amount of acreage needed to have up to 4 horses from 2.5 acres to 5 acres. Ballots were sent to all the property owners in April Cove. Both changes were not passed.

Spring has sprung and summer is right around the corner. Time to put some spit and polish on our Cove to get it ready for the summer season.


Current To Do List:

- -The Southern Oaks Volunteer Fire Department will conduct the first test of their **Emergency Warning Siren** system on May 13 at 1:00 pm. The siren will be activated on the second Monday of each month at 1:00 pm for a monthly test. If the siren is heard at any other time, day or night, seek shelter immediately. The sounding of the siren indicates that a tornado or other serious weather event is likely.
- -Community National Bank and Trust branch office located in front of April Cove is **now open Tuesday & Thursday: Lobby 9 am-3 pm; Drive-Thru 8:30 am-4 pm**. Their Bank Board had voted to close the branch, but our community came together to show the Board the need for their services here. The Board conceded to keep the bank open two days a week. The ATM is available 24 hours a day.
- -Sweet Sisters Vintage Market is now open at 385A FM416, next to the hardware store. Hours are Tues. thru Fri. 10 4 & Sat 10 2. This is another small business in our community that needs our support.
- -Opening this summer: Corsicana Water and Adventure Park located at I-45 & US Hwy 287.

Warranty repairs were attempted but the rain made it too wet and some of the repairs did not work. Once the weather dries out, the warranty repairs will once again be made and then the 2019 road maintenance plan will be executed.





AIR AMBULANCE SERVICES

Hopefully you will never need it, but if you do, a Air Ambulance helicopter ride can be expensive. At the Annual Meeting Van Wagnon, April Cove resident and Chief of the Southern Oaks Fire Department, presented two helicopter Insurance programs that serve our area. Van went on to say that during the construction of an addition to the church he got cut. The medical facility in Fairfield had trouble controlling the bleeding. The decision was made to fly him to Waco by Air Ambulance where he could be treated. A few weeks later he received a bill that was over \$50,000 for the Air Ambulance service. Fortunately he did have the insurance and it cost him nothing. Van wanted to make sure that the residents of April Cove knew that these two services covered our area plus much larger areas.

Because of where April Cove is located relative to the nearest hospital an Air Ambulance flight might be the only way to save your life in an emergency, these plans are also designed to save your bank account.
