Reports:

<u>Chairman's Report</u>: Commissioner Graff informed the Board that he spoke with the District's accountants earlier today about the 2019 Budget. He reported that there is a surplus of \$589,000.00 from the 2019 Budget, He said this was the same year Local 553 was given a salary increase.

Commissioner Graff and Commissioner Mannone discussed the possibility of having a tax cut for 2021 to reflect the 2019 savings. Commissioner Graff said this was good news and showed that the Board is handling the finances well.

<u>Supervisor Catapano</u>: Supervisor Catapano said he is done ordering the uniforms for Local 553 and that he is waiting for final proposals for CSEA uniforms. He reported that everyone is doing a great job and there are no problems.

<u>Committee Reports</u>: Commissioner Graff discussed the vacancies due to Commissioner Horowitz stepping down. He asked Commissioner Hemsley if he would fill those vacancies. Commissioner Hemsley said he would like to think about it before committing.

Budget: No new business to report.

Insurance: No new business to report.

Public Relations: No new business to report.

Personnel: No new business to report.

<u>Ethics</u>- Commissioner Graff said he would be meeting with the attorney during February regarding an updated Code of Ethics.

<u>IT</u>: Commissioner Doherty said he will pick up where Commissioner Horowitz left off regarding the new computers.

Commercial Pick-Up: No new business to report.

Unfinished Business:

Community Development Block Grant Disaster Recovery (CDBG-DR) Program (NY Rising Community Reconstruction Program)-Commissioner Graff said the contractor was at the District and the roof project should start in March.

<u>Fuel Tank Project</u>- Commissioner Graff stated the District is waiting for an inspection and Nassau County Department of Health's permit to complete the project.

Code of Ethics-as previously discussed.

Commercial Pick Ups-No new business to report.

Solar Panels-Tabled

<u>Uniforms</u>-Supervisor Catapano previously reported on this.

<u>Ticket Policy</u>- Commissioner Graff said he would like this removed from the Agenda because it will be included in the Employee Handbook.

MOTION

On Motion by Commissioner Mannone and seconded by Commissioner Samoles to remove the Ticket Policy from the Agenda and to include it in the District's Employee Handbook. Unanimously approved.

New Business:

EFPR Group-The Board discussed the proposal for the auditor's work for 2019.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Doherty to retain the EFPR Group per their proposal. Unanimously approved.

2018 Financial Statements-Commissioner Graff stated the Board received copies of the financial statements for their review.

MOTION

On Motion by Commissioner Mannone and seconded by Commissioner Doherty to approve the 2018 Financial Statements. Unanimously approved.

<u>2020 Election</u>- Commissioner Graff said the District used Bold Systems in the 2019 Election to provide the voter registration books. The Board discussed the proposal for 2020.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Mannone to retain Bold Systems for the 2020 Election. Unanimously approved.

<u>Dee's Nursery</u>-Commissioner Graff said the District received a letter from Dee's Nursery requesting additional pick-ups. He also said they will have to pay \$71.70 for an additional day. Commissioner Doherty asked if it is a case by case basis for additional commercial pick-ups. Commissioner Graff confirmed this.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Mannone to approve an additional pick-up on Saturday's for Dee's Nursery at a cost of \$71.70 per pickup. Unanimously approved.

Employee Buy Backs-

MOTION

On Motion by Commissioner Doherty and seconded by Commissioner

Samoles to approve the following Buy Backs for CSEA employees at their 2020 pay rate. John Colalillo 50 Banked Vacation Days and 20 Sick Days, Jay Tavalaro 20 Sick Days, Frank Licari 20 Compensatory Days and 10 Banked Vacation Days and Frank Licari 30 Sick Days and 10 Banked Vacation Days for Deferred Compensation. Unanimously approved.

<u>Purchase of New Trucks</u>-The Board discussed the need for additional sanitation trucks. Supervisor Licari explained the need to replace to two nineteen year old trucks. He said the cost would be \$196,000.00 per truck. Supervisor Licari said with thirteen trucks going out that it is tight fulfilling that need. Supervisor Catapano stated that if two trucks go out of service there would be a problem.

Commissioner Samoles questioned Supervisor Licari regarding purchasing refurbished trucks. Supervisor Licari said he does not recommend buying refurbished trucks because of the cost and the unknown length of time refurbished trucks would last.

Commissioner Mannone said he only wants one truck purchased now and a second after the 2021 Budget is complete. Commissioner Graff stated he would like two trucks purchased now because it takes eight or nine months to receive a truck once ordered. Commissioner Doherty said that since there is excess money from 2019 he thinks two trucks should be purchased.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Hemsley to approve the purchase of two sanitation trucks on state bid. Unanimously approved.

<u>Sale of Old Trucks</u>- Commissioner Graff said there are two trucks in the back lot that cannot go out on the road. Supervisor Licari said everything the District can use has been removed from the two trucks and they are ready to be sold. Commissioner Doherty asked how they will be sold. Supervisor Licari also explained the sealed letter bid process that he used in the past.

MOTION

On Motion by Commissioner Doherty and seconded by Commissioner Samoles to sell two sanitation trucks by sealed letter bid subject to Board approval. The bid opening is to take place on April 2, 2020 at 6:30 p.m. Unanimously approved.

<u>Employees</u>- Commissioner Graff said Artie Schnabel was promoted to Supervisor and the Board needs to fill the full time Sanitation Worker position. Commissioner Graff said the most senior part-time Sanitation Worker will fill the position.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Graff to appoint Luke Mihale as a full-time Sanitation Worker with a starting salary of \$30,770. Commissioners Graff, Mannone, Samoles and Hemsley approved. Commissioner Doherty abstained. Motion passes.

Public Comment Period:

Joseph Cibellis questioned why the Legal Fees for 2019 were 50 % over budget when there are two attorneys on the Board. Commissioner Graff said it was due to previous litigation in 2019.

Mr. Cibellis demanded why the insurance fees are 580% over budget for 2019. Commissioner Graff disputed Cibellis accounting, to which Cibellis acknowledged he was confused and really meant Accounting Fee and not insurance Fees. Commissioner Graff stated the District does not have a Treasurer due to a termination and that it is pending arbitration. He said once the arbitration is over the Board will know if they can hire a new Treasurer.

Mr. Cibellis inquired where his FOIL request is. Commissioner Graff said as previously discussed, Steve Cohn needs to send a letter to the District. Mr. Cibellis said Mr. Cohn has nothing to do with his personal request for information. Commissioner Graff asked Attorney Ciampoli to look into the matter.

Mr. Cibellis asked who authorizes overtime. Commissioner Graff answered that the Board of Commissioners does.

Mr. Cibellis asked Commissioner Graff what he meant by the quote in the Oceanside Herald when he said he wanted to make sure that the vetting process and the process to fill the position was not infected with politics. Commissioner Graff said after Commissioner Horowitz stepped down he spoke with stakeholders of the District including taxpayers, employees and others to find a suitable candidate. He said based on this the Board selected Commissioner Hemsley.

Commissioner Graff said the past elections had been very, very contentious and he did not want the appointment process to be contentious. Mr. Cibellis asked for the names of the people he spoke to. Commissioner Graff said he would not reveal the names.

Mr. Cibellis asked if anybody was terminated for the \$1200.00 error in his medical insurance bill. Commissioner Graff said Mr. Cibellis paid for the error and the error was the accountant's mistake.

Mr. Cibellis asked how and why the appointment of a Supervisor was done at a Special Meeting. Commissioner Graff said five people submitted applications from Local 553 that had their CDL. He said the five were interviewed and then the Board made a selection. Mr. Cibellis asked if seniority was considered. Commissioner Graff said seniority had nothing to do with it. Commissioner Doherty stated he had nothing to do with the process and he did not even know who applied.

MOTION

On Motion by Commissioner Samoles and seconded by Commissioner Doherty to enter into Executive Session. Unanimously approved.

EXECUTIVE Board went into Executive Session at 7:13 p.m. to discuss matters

SESSION involving personnel, pending litigation and for the purpose of soliciting and receiving legal advice.

MOTION On Motion by Commissioner Samoles and seconded by Commissioner Doherty to exit Executive Session at 9:50 p.m. Unanimously approved.

MOTION On Motion by Commissioner Doherty and seconded by Commissioner Samoles to approve the budget adjustments per the attached memo dated February 6, 2020 from Rynkar, Vail & Barrett. Unanimously approved.

The next General Board of Commissioners Meeting will be held on Thursday, March 5, 2020 at 6:30 p.m.
