Unfinished Business:

Community Development Block Grant Disaster Recovery (CDBG-DR) Program (NY Rising Community Reconstruction Program)-Commissioner Mannone stated the District is still waiting to hear back from GOSR.

<u>Fuel Tank Project</u>- Commissioner Lanning said the new fuel tank is on order and should be delivered in a few weeks.

<u>2019 Election</u>-The Board discussed the proposal from Bold Systems, as well as previous election processes.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Doherty to table matters regarding the 2019 Election. Unanimously approved.

By-Laws -

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to table the By-Laws update regarding election procedure. Unanimously approved.

<u>CSEA-CBA Negotiations</u>-Commissioner Mannone discussed waiting until after Local 553's contract is finalized before negotiating the CSEA collective bargaining agreement.

New Business

<u>Employee Retirement</u>-Commissioner Graff thanked Supervisor Wayne Vurture for his years of service.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Doherty to accept the retirement of Wayne Vurture. Unanimously approved.

<u>Robert's Rules-By-Laws Update</u>-Commissioner Mannone stated he sent an update to the Board and would like the Commissioners to consider his proposal.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to accept the settlement agreement of \$300,000 between Michael Scarlata and Charles Scarlata and the District to settle the case Index number 6034662017. The settlement will be paid as follows: \$200,000 to be paid by April 8, 2019, \$33,000 to be paid by April 8, 2020, \$33,000 to be paid by April 8, 2021 and \$33,000 to be paid by April 8, 2022. Unanimously approved.

Commissioner Mannone stated the settlement took a lot of work and he thanked Commissioner Graff regarding the taxpayer lawsuit. He said this ended a chapter of money being taken inappropriately.

Commissioner Lanning made a statement regarding the Herald article from the prior week. He said John Iovino of Bender Insurance was not fired. The principles from his firm felt there was a conflict and they sent an email that they no longer wanted to represent the District.

Commissioner Lanning stated that when the District sent out RFP's for insurance, accounting and legal services the prior firms did not want to work with the District including Harris Beach and Forchelli Curto & Deegan.

Commissioner Lanning said the audience may not have seen Channel 12 News or Newsday regarding District problems. Commissioner Lanning then asked Commissioner Horowitz to step down as a commissioner because of the issues he has.

Public Comment Period:

Joseph Cibellis stated that the District's Code of Ethics states that a Commissioner that violates the Code of Ethics can be removed from office. Mr. Cibellis stated he could provide proof of gross misconduct.

Mr. Cibellis stated Commissioner Mannone assisted in writing a grievance for an employee and did not reveal his relationship to that employee. Mr. Cibellis also stated that Commissioner Mannone witnessed a female employee being harassed and that he leaked information from Executive Session.

Mr. Cibellis said that Commissioner Mannone accused employees of wrongdoing without proof. Mr. Cibellis stated that the Board gave an average of a 20% increase to the Sanitation Worker's salaries and eliminated a job title because of economic reasons. Mr. Cibellis also said that Commissioner Mannone never revealed his wife worked for Michael's Electric while the District went into contract with them for \$25,000.

Mr. Cibellis stated Commissioner Doherty never recused himself from contract negotiations and gave huge raises to Local 553. He also said Commissioner Doherty witnessed inappropriate behavior and did nothing.

Mr. Cibellis stated that Commissioner Graff's social media posts involved personnel and that the employees were not given their due process. Mr. Cibellis said that Commissioner Graff never provided proof that he no longer represented a sanitation worker in a lawsuit against the District. He also said Commissioner Graff witnessed harassment and did nothing about it.

Joseph Samoles said the Board was doing a great job and that he was pleased there is no consultant or other criminals at the District.

Ed Scharfberg questioned if money had been put aside for the GOSR project. Commissioner Mannone said that there are discretionary funds in the Building and Land Reserve for the project.

Ed Scharfberg asked how much the District has spent on accounting fees. He was told the Board did not have an exact figure, but the firm is paid on an hourly basis.

Ed Scharfberg questioned who was conducting safety training for the District. Commissioner Graff said a committee was being formed and that Supervisors and the insurance company are doing the training. Mr. Scharfberg asked if the Supervisors were trained and Commissioner Graff confirmed that they are trained.

Ed Scharfberg asked if sitting commissioners are indemnified by the District's insurance company. Commissioner Graff confirmed that they are.

Ed Scharfberg stated that while he was a commissioner it was common practice that commissioners were offered to pay for their insurance after their term if they wanted to continue benefits. Mr. Scharfberg said in 2014 the Board offered the benefits to a commissioner but she declined. Commissioner Graff stated that in April 2018 a former commissioner was put back on the dental coverage without Board knowledge.

Commissioner Mannone said he did not help write the complaint that led to the lawsuit. Mr. Scharfberg stated that on two occasions Commissioner Mannone stated that the lawsuit would go away if the worker was put back in position.

Mr. Scharfberg also stated that while he was on the Board the March 2018 Minutes could not be approved. Mr. Scharfberg stated Commissioner Mannone removed comments made by Mr. Scharfberg and waited until after Mr. Scharfberg left the Board to have the March 2018 Minutes approved.

Mr. Scharfberg stated that some members of the Board are a detriment to the District. Commissioner Mannone stated it was a shame how they started off together against anti-corruption and they no longer agree.

James Mitchell stated that he and Chairman Mannone both know that Commissioner Mannone has serious ethical and political issues. Mr. Mitchell said he has direct knowledge and proof and asked Commissioner Mannone to step down and resign from the Board. Commissioner Mannone said he tried to be fair and extend friendship and compassion towards Mr. Mitchell.

Megan Mitchell asked the Board why the District has no sexual harassment policy. Commissioner Mannone stated that there is one.

Ms. Mitchell asked if Mrs. Urli has protection when she is forced to be with the accused. Ms. Mitchell also asked if anyone has apologized to Mrs. Urli. Commissioner Mannone stated he could not comment because it is a matter of litigation.

Ms. Mitchell asked if there is any evidence that James Mitchell's position was made solely for him. Supervisor Jerry Liotti stated he had been completing job duties under the messenger position. Commissioner Mannone stated Mr. Mitchell was working out of title and that there was such corruption and positions were created to hand out jobs.
