Reports:

Chairman's Report: No new business to report.

Supervisor Catapano:

Supervisor Catapano said on Saturday, April 13th the Oceanside Library children's program will be at the District for a recycling lesson.

Supervisor Catapano stated two part-timers started since the last Board meeting.

Supervisor Catapano said the District's annual E-Cycling Shed-the-Meds and document shredding will take place April 27th.

He also stated that CSEA and Local 553 employees are doing a great job together. Commissioner Graff thanked the employees for their hard work in 2019.

Committee Reports:

Budget: No new business to report.

Insurance: No new business to report.

Public Relations: No new business to report.

Personnel: No new business to report.

Ethics- No new business to report.

Unfinished Business:

Community Development Block Grant Disaster Recovery (CDBG-DR) Program (NY Rising Community Reconstruction Program)-Commissioner Mannone said the project is moving forward.

<u>Fuel Tank Project</u>- Commissioner Lanning said the new fuel tank is finished and needs to be transported to the District. He said it should be within a month.

<u>2019 Election</u>-Commissioner Graff said the agreement with Bold Systems is in place. He said they will use the voter list from the Nassau County Board of Elections to make the District's voter list.

By-Laws —Commissioner Mannone stated he would like Attorney Ciampoli to look into and help address the District's By-Laws regarding the annual election.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to table the By-Laws update regarding election procedure. Unanimously approved.

<u>CSEA-CBA Negotiations</u>-Commissioner Mannone stated the Board is waiting until after Local 553's contract is finalized before negotiating the CSEA

collective bargaining agreement. Commissioner Mannone stated Local 553's contract is with District Counsel. Attorney Ciampoli stated he spoke with prior Counsel and he will be getting the files and finishing the contract.

Commissioner Lanning said the Board signed the MOA in November. He and Commissioner Mannone stated that the contract was taking too long to complete. Commissioner Mannone said prior counsel did not pursue the completion of the contract.

Robert's Rules-By-Laws Update -Commissioner Mannone stated he would like to amend the By-Laws to follow Robert's Rules so there would be more order at meetings. Commissioner Graff asked for a copy of the changes.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Lanning to table the amendment to the By-Laws regarding Robert's Rules. Unanimously approved.

<u>Part-time Worker</u>-Supervisor Catapano said Jorge Carrion stopped showing up for work in February 2019. The District tried to reach him by phone, in person and by mail. Mr. Carrion has not responded.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to terminate part time Sanitation Worker Jorge Carrion, effective immediately. Unanimously approved.

New Business

<u>Community Events-</u>Oceanside Jewish Center Pre-K Program requested that the District bring trucks to their Community program on June 5th.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to approve manpower and equipment for the Pre-K program at the Oceanside Jewish Center on June 5th. Unanimously approved.

St. Anthony's RC Church requested assistance for their annual Feast held June 6^{th} through June 9^{th} .

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Lanning to approve manpower and equipment to assist at the St. Anthony's Annual Feast from Thursday, June 6th through Monday morning, June 10th. Unanimously approved.

Commissioner Graff discussed commercial businesses in town. At his first meeting he asked the driver's to track the number of dumpsters picked up from commercial businesses. Commissioner Graff studied this and found that some businesses get picked up every day while others do not get picked up at all.

Commissioner Graff said he asked the Supervisors why there is a discrepancy and they told him that that is the way it has always been done. Commissioner Graff said that this was not acceptable and that the unfair practice has to stop. He wants the Board to set the policy for commercial pick up.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz that effective April 29, 2019, any business where the District picks up dumpsters will be limited to four dumpsters per pick up and pick up be limited to three days a week. Any business that has an excess of four dumpsters can request permission from the Board, based upon hardship or other business-related explanation why the District should pick up additional dumpsters at the business or increase the number of days. This limitation to four dumpsters and three day a week pick up excludes the school district buildings, the fire district and the firehouses, residential complexes, and religious organizations.

DISCUSSION

Commissioner Mannone stated it is not prudent for Commissioner Graff to make the motion. He said that this opens the District to additional claims and litigation.

Commissioner Graff again stated that the commercial pick- ups are unfair and one business has eighteen dumpsters per day and other businesses have no pick-up. He said there should be no difference regardless of the business. He also said it would not have an effect on a large majority of the businesses currently getting picked up. Commissioner Graff also stated that the District can open up pick-ups to other businesses.

Commissioner Mannone agreed with Commissioner Graff and said it would help with ending the culture of corruption. Commissioner Mannone said they need further discussion to develop policy unilaterally. He stated former Commissioner Jean Kramer looked into this and it is a complex issue. He also said the Board needs to look at the tax basis and do further research.

Commissioner Lanning stated the April 29th date was too quick and questioned Commissioner Graff regarding inviting all businesses to request pick up. Commissioner Graff confirmed that all businesses can request pick up. Commissioner Lanning stated that the District may need more manpower and more trucks if inviting all businesses to request pick up. He said he needs more information before a decision is made.

MEETING #3369

Commissioner Mannone stated the Board needs more time to analyze this issue. He said any policy has to address the revenue the District receives from commercial businesses. Commissioner Graff said they could limit the motion to only the businesses that are currently getting services.

VOTE

Commissioners Graff and Horowitz approve. Commissioner Lanning abstained and Commissioner Mannone opposed. Motion fails.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to approve Sele-Dent's proposal dated March 9, 2019 so that Sele-Dent will become the District's dental claims administrator, provide dental claims administration and network access to their dentists for the hard working drivers and loaders in Local 553 and authorize the Board Chairman to execute the contract with Sele-Dent. Sele-Dent will commence administration of the District's dental claims as soon as possible. Since the dental claims administrator will provide professional services to the District, no RFP was required. The proposal has an approximate cost of \$28,000 per year to the District. Unanimously approved.

Public Comment Period:

Dan Faust said that several times he requested a letter for his January 2019 medical insurance and he still has not received it. Attorney Ciampoli stated he will send it tomorrow and requested Mr. Faust's email address.

Mr. Faust asked who was in charge of the health insurance at the District. Commissioner Mannone said the District no longer has an employee to handle it. He then said the District's accountants and counsel were in charge.

Vincent Markus questioned why Wayne Vurture, the benefits administrator, was not terminated. He questioned the time frame and the reasons for the December terminations. Attorney Ciampoli said it is a matter of litigation and grievances. Meagan Mitchell stated that Commissioners Mannone posted a video on YouTube and Commissioner Graff made Facebook posts regarding the matter so they should talk about it at the meeting.

Attorney Ciampoli recommended the matter be discussed in Executive Session. He did state that hearings had been rescheduled. Commissioner Mannone said once finished he will answer all questions concisely.

<u>APRIL 11, 2019</u>

Joseph Cibellis asked if the District had a social media policy. Commissioner Graff said there is no policy and any restrictions would violate the First Amendment. Commissioner Mannone agreed with Commissioner Graff.

Commissioner Mannone, Commissioner Graff and Mr. Cibellis discussed Mr. Cibellis' dental insurance. Mr. Cibellis stated an error was made by the District and he spoke to Wayne Vurture about the matter in February or March 2018. He said he only spoke to Doug Hernandez regarding the cost of the insurance. Mr. Cibellis paid over \$2000 a month for health insurance since he completed his term as commissioner. Mr. Cibellis stated the Board fired people over a mistake.

Commissioner Graff asked Mr. Cibellis if he received money from AirStream. Mr. Cibellis said no. Commissioner Graff then asked Mr. Cibellis if he ever did work for AirStream. Mr. Cibellis would not answer.

Mr. Cibellis questioned who is in charge of the District's flag. Supervisor Liotti said he was in charge. Mr. Cibellis said the governor had requested the flag be at half-mast for soldiers that were killed. Supervisor Liotti stated he would take care of it.

Mr. Faust asked why the port-o-potty was strapped and if the District is ADA compliant. He was not given an answer.

Meagan Mitchell asked the Board if they were familiar with Section 3 of the Code of Ethics. She stated they Board was in violation of the code. She then asked Commissioner Graff if he witnessed lewd comments made by Commissioner Horowitz to or about the secretary. Commissioner Graff responded "No". Ms. Mitchell asked Commissioner Mannone the same question and he did not respond. Ms. Mitchell asked Commissioner Horowitz if he ever made lewd comments to or about the secretary. He stated it was under litigation. Marcia Horowitz questioned Ms. Mitchell about the information she has.

Ms. Mitchell then asked Commissioner Graff if he called Mrs. Urli a liar. He said he did not. Commissioner Graff said that he said Mrs. Urli made false claims. Commissioner Mannone then made a statement to Ms. Mitchell telling her to do something. Ms. Mitchell then asked if the Commissioners were misogynists.

Ms. Mitchell asked what Tony Iovino working at the library has to do withMatt Horowitz asking Jackie Urli to have a three way. Commissioner Horowitz asked how does Ms. Mitchell know that information. Commissioner Graff said it was an inappropriate question. Commissioner Mannone questioned Ms. Mitchell if she really believed that. Commissioner Horowitz wanted it on the record that Ms. Mitchell called him a pervert, abuser and predator.

Joe Samoles asked Commissioner Lanning where he stands regarding the illegal benefits Mr. Cibellis received. Mr. Cibellis stated he never received illegal benefits. Commissioner Lanning stated he also does not believe Mr. Cibellis received illegal dental benefits.

Mr. Samoles asked why Commissioner Lanning did not vote to give the men raises. Commissioner Lanning said he did not vote against the contract, he abstained. He said Commissioner Doherty's nephew is the Shop Steward and he believes there is a conflict of interest and is against the Code of Ethics. Commissioner Lanning stated he was concerned about a problem in the future and that is why he abstained from the vote.

Mr. Cibellis questioned if it was proper to pay the raises without the completion of the contract. Commissioner Graff stated it was fine because both sides agreed and signed the MOA. President Dan Gatto of Local 553 also confirmed this.

Mr. Cibellis inquired about his F.O.I.L. request regarding the District's Sexual Harassment Policy. Attorney Ciampoli said the Board adopted the NYS Standard Policy and he would ask prior counsel for it.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to enter into Executive Session. Unanimously approved.

SESSION

EXECUTIVE Board went into Executive Session at 7:39 p.m. to discuss matters involving the employment history of particular persons, pending litigation and for the purpose of soliciting and receiving legal advice.

Commissioner Lanning left at 7:40 p.m.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to exit Executive Session at 8:03 p.m. Unanimously approved.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to accept the resignation of Susan Nadler for the position of the Treasurer. Unanimously approved.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to re-enter into Executive Session until 8:30 p.m. to discuss matters involving the employment history of particular persons, pending litigation and for the purpose of soliciting and receiving legal advice. Unanimously approved.

The Board will hold a Special Meeting on Tuesday, April 16, 2019 at 6:30 p.m. for personnel matters.

The next General Board of Commissioners Meeting will be held on Thursday, May 2, 2019 at 6:30 p.m.
