<u>Chairman's Report</u>: Commissioner Mannone stated that he is pleased that the Board has met numerous times regarding the CBA with Local 553 and is looking forward to a successful conclusion.

General Supervisor Faust:

AT & T was at the District on August 22nd regarding the push to talk radios. A September 7th conference call is scheduled to set up the phones.

General Supervisor Faust had Supervisor meetings on August 16th and September 4th.

Landtek returned and completed the roof repair on August 9th and 10th

Rynkar, Vail & Barrett were at the District on August 15th for their quarterly review.

The e-cycling, shed the meds and document shredding program is scheduled for Saturday, September 15th from 10:00 a.m. until 2:00 p.m. A robo-call is scheduled for September 13th at 7:00 pm.

General Supervisor Faust requested the purchase of one packer as per the new equipment budget line. Supervisor Licari recommended either going out for bid or possibly purchasing through Sourcewell-a state approved agency.

Committee Reports:

<u>Budget</u>: Commissioner Horowitz stated the 2019 Budget will be completed by the Special Meeting on September 13th.

<u>Insurance</u>: No new business to report.

<u>Public Relations</u>: The E-cycling, Shed the Meds and document shredding will take place September 15th.

<u>Personnel</u>: Commissioner Graff stated the Board met with Local 553 on September 5th in Executive Session.

Unfinished Business:

<u>Pavement Project</u>- Navigators is closing the claim. A check for \$2,725.50 will make the total reimbursement \$78,459.

MOTION On Motion by Commissioner Graff and seconded by Commissioner Horowitz to table the discussion. Unanimously approved.

<u>Rear Building Project</u>- Bill Brenan sent an email stating he is waiting for the closing documents from Landtek.

Community Development Block Grant Disaster Recovery (CDBG-DR) Program (NY Rising Community Reconstruction Program)-The next scheduled meeting is September 24th.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to table the fuel tank bid discussion and discuss in Executive Session. Unanimously approved.

MOTION

<u>Commercial Businesses</u>-The Board discussed the need to record the number of dumpster pick-ups during October and January before an analysis can be completed.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to table the Commercial Businesses until the October Meeting. Unanimously approved.

New Business:

Medical and Dental Benefits- The Board discussed the health and dental benefits of retired employees and former Commissioners. Commissioner Graff raised the issue of eligibility. Treasurer Hernandez stated that retirees can keep their dental benefits through CSEA if they pay for them. Healthplex does not offer this option. The Board requested Treasurer Hernandez to inquire if the dental payments can be paid directly to CSEA and eliminate the District from receiving and processing payments on behalf of retired employees. Attorney Corbett stated he has not reviewed this matter.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Doherty to amend the by-laws to bar former Commissioners and former employees from paying into dental program through the District. Commissioner Lanning abstained. Commissioners Graff, Mannone, Doherty and Horowitz approved. Motion passes.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to direct Secretary Urli to send COBRA notices regarding dental coverage to CSEA retired employees and former Commissioners within the next ten days. Commissioners Lanning and Doherty abstained. Commissioners Mannone, Horowitz and Graff approved. Motion passes.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Lanning to amend the by-laws and to immediately prohibit former Commissioners from receiving medical benefits through the District. Unanimously approved.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Doherty to direct Secretary Urli to send COBRA notices regarding medical coverage to former Commissioners within the next ten days. Unanimously approved.

<u>2019 Calendar</u>-The Board discussed the need for the calendar to inform the public of the holiday schedule. Two quotes were obtained. PIP Printing was \$4,366.64 and Minuteman Printing was \$3,913.65 for the production and mailing of the 2019 postcard calendars.

MOTION

On Motion by Commissioner Doherty and seconded by Commissioner Horowitz to award the 2019 Calendar printing and mailing to Minuteman Printers at a cost of \$3,913.65. Unanimously approved.

2019 Budget-Tabled

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Doherty to table the discussion of the 2019 Budget due to the Town of Hempstead on September 17, 2018 to the Special Meeting scheduled for September 13, 2018. Unanimously approved.

<u>Sanitation Truck Bid</u>-Commissioner Horowitz stated that the District would purchase one truck a year for the next five years. The Board discussed using a vendor approved through the New York State procurement office.

MOTION

On Motion by Commissioner Doherty and seconded by Commissioner Graff for General Supervisor Faust to obtain a quote for a new sanitation truck through Sourcewell, an approved New York State vendor. Unanimously approved.

Voter Registration- Commissioner Graff stated he would like New York State voter registration forms and Oceanside library registration forms available to the public at the Shed the Med, E-Cycling Day event. Commissioner Lanning stated he would want this discussed when the Board discusses the 2019 Election.

MOTION

On Motion by Commissioner Graff and seconded by Commissioner Horowitz to have the District place New York State and Oceanside Library voter registration forms at the District event to be held on September 15, 2018. Commissioner Lanning Opposed. Commissioners Mannone, Doherty, Horowitz and Graff approved. Motion passes.

Business Manager Position-Commissioner Mannone asked Commissioner Graff to discuss this in Executive Session.

Public Comment Period:

Guy Tricarico asked if the District could ask voters for identification. Attorney Corbett stated that that was not permissible. Commissioner Lanning said the Board would be discussing the election process after the CBA with Local 553 and the 2019 Budget is completed.

On Motion by Commissioner Horowitz and seconded by Commissioner Doherty to enter into Executive Session. Unanimously approved.
