## **PUBLIC COMMENTS**

The Treasurer and General Supervisor offered input as to the budget numbers. Employees are on different steps, taking insurance into consideration. Faust felt it was fair and congratulated The Board on the budget.

Mr. Cibellis asked if the Commissioners are receiving benefits. Chairman Mannone asked if he is referring to health and dental, and said yes there are. Mr. Cibellis asked if there was a motion a few years ago to do away with them? Yes, but they were grandfathered in at that time. Mr. Cibellis asked for a copy of the budget. What is the holdup with the foils? It's been 3 years and several people have asked. Cibellis received his foil, but Doug Hernandez's is still outstanding. The Secretary was asked to provide current address. Mr. Cibellis asked Chairman Mannone to explain his treatment to the taxpayers. Chairman Mannone said I will not.
