Shop Steward D'Ambrosio asks if it is not maintained by the Town of Hempstead, then what happens if somebody gets hurt on that road?

Commissioner Beckman replies I am in real estate, if it is a private road, usually there is an agreement by the residents that they will upkeep it and pay for a sewer joint. They are liable. They are supposed to have insurance.

Shop Steward D'Ambrosio replies thank you to Commissioner Beckman. States that the road is a nightmare to drive down.

Commissioner Beckman states she wants to find out of they have an association that pays.

Commissioner Mannone asks can you find that out?

# PUBLIC COMMENTS

Mr. Cibellis ask about the 10 percent increase.

Commissioner Mannone replies I'm assuming you're referring to taxes but going. We just got in there where we have inflationary expenses. So, our initial thing is that we're talking about a tax increase or where we have a budget shortage right now.

Commissioner Beckman states we are trying to figure out other ways.

Commissioner Mannone states we haven't decided.

Mr. Cibellis states he does not understand if they are 10 percent over the budget or you need 10 percent.

Commissioner Mannone states we are short. We have price increases from inflationary price increases. Inflation has gone up about 10 percent.

Mr. Cibellis asks how can a budget that big be 10 percent over?

Commissioner Samoles states that everything costs more. From fuel to employee wage.

Commissioner Mannone states we do not know how much over. So, this is a preliminary thing, because it's a certain amount of guess work because we don't know what the rate of inflation is going to be yet. We have started. If you have watched, we kind have started with the assumption that it is going to be much worse then we anticipated. We have not looked at how to cut expenses.

Commissioner Beckman states health insurance has gone up everything has gone up. As in the rest of the country.

Mr. Cibellis states he understands that, but how big is the budget this year overall?

Commissioner Beckman states she does not have a final number yet.

### PUBLIC COMMENTS

Commissioner Mannone ask you are talking about last years, not the one we are going to be enacted? It is about 9.2.

Mr. Cibellis asks how much could that possibly go up from inflation?

Commissioner Mannone states they way we are looking at it. I do not want to say that it is, because we do not know what the inflationary impact is. It looks like we might be having double digit inflation. So, we assume based on that assumption, we could be running a 1.2 deficit on it so far. So, we might have to take austerity measures to make everything balance or at least try to bring down the numbers. But I'll keep you posted as well as the rest of the public as we're going along to see that.

Commissioner Beckman states the next budget meeting is August 9th.

Mr. Cibellis asks is that 10 percent on 9 million?

Commissioner Beckman replies no, that is not what we are talking about. It is a possible tax increase of 10 percent last year.

Commissioner Mannone states move on to the next question. Joe Cibellis, \$100,000 in oil. Are you asking is that we budgeted?

Mr. Cibellis' comment is inaudible.

Commissioner Mannone replies I do not recall. I do not have that. Unfortunately, our treasurer is not in, so I'm not exactly sure. It may have been if you heard it, but I could verify for you

Mr. Cibellis asks do we use oil, I thought it was gas here. Am I wrong?

Commissioner Mannone replies we also use oil for the trucks as well.

Commissioner Beckman states but it is the diesel that we were talking about.

Commissioner Mannone states that would have been fuel. So, I'm not sure what you're referring to the hundred and oil. I'd have to look at the line item. It doesn't sound right either. It might have been that that was a reference we were speaking we referred to it as oil, but it might have been gasoline that we're talking about.

Commissioner Mannone reads the next question. Are residents allowed dumpster?

# PUBLIC COMMENTS

Mr. Cibellis states he received some phone calls, that asked are residential homes entitled to dumpsters.

Commissioner Mannone states I don't know what the policy is on that. Obviously, commercial we have commercial dumpsters. I don't know if there are any existing dumpsters that are on residential properties. Are there any exceptions to that? Because as far as I know, we don't have any residential dumpsters on properties.

Mr. Cibellis asks so if someone is doing a project there is no reason, they should have an Oceanside Sanitation dumpster in front of their home.

Mr. Ciampoli states we do not provide them, even commercial, the owners responsibility to purchase or rent.

Mr. Cibellis's statement is inaudible.

Commissioner Mannone asks do you know the address?

Mr. Cibellis replies not exactly but it is on Montgomery.

Commissioner Beckman states find out the address and we will check it out.

Commissioner Mannone state we have not gotten anybody saying anything about a dumpster on Montgomery.

Commissioner Samoles states his son-in-law ripped up his backyard and he borrowed a dumpster for a couple of day until it was done. We have done that in the past, for supervisors, we have done it for past employees. If you work for sanitation, we do lend it out for a couple of days. It is nothing against the law. It is easier for the guys to pick up.
