Welcome to your Library



Our Policy

The Gaynor Family Regional Library strives to provide everyone with fair and equitable access to a wide range of library services in a welcoming environment that is free from discrimination and harassment. Everyone has the right to equal treatment with respect to the access and use of the Library's services and facilities in accordance to the Manitoba Human Rights Code.

We maintain a zero-tolerance policy regarding all forms of discrimination and harassment to fellow patrons and Library staff. These rules are intended to prevent such conduct and to ensure the dignity and safety of all and to maintain the security of library property without disruption to library services.

Staff make every effort to apply these rules in a fair, dignified and positive manner for the benefit of all. We ask your cooperation in maintaining a welcoming environment conducive to study and enjoyable use of the Library.

The follow points will not be supported or allowed:

- Threatening, abusive, discriminatory or harassing language or conduct of any kind to fellow patrons or Library staff
- Damage, misuse, or theft of library materials, equipment and property including interfering with the designated use of computers and library networks
- Disruptive or intrusive behaviour

- Members of the public may not make requests for service based on prohibited grounds of discrimination under the Human Rights Code
- Children requiring supervision must not be left unattended on library premises
- Members of the public may only use authorized entrances and exits and are not allowed in "Staff Only" areas without permission
- Members of the public may be asked to open all bags, books and papers for inspection should theft be suspected by staff
- Library materials may not be taken into washrooms
- Posting notices, distributing circulars or petitions, soliciting or engaging in any commercial activity on library property must not be conducted without prior written approval of the Library
- Photographing, filming or video recording on library property must not be conducted without prior written approval of the Library
- Members of the public must wear shirts and shoes and other appropriate attire
- Use of sports equipment NOT ALLOWED in the library includes unicycles, bicycles and tricycles
- Use of sports equipment ALLOWED in the Library, but require items to be stored in an out-of-the-way location NOT stored in any aisle/walkway/foyer (scooters, skateboards, wagons, strollers, baby carriages/prams, walkers, wheelchairs)
- Eating is not allowed at public computers
- Animals are not permitted in the Library space, except in authorized programs or when needed as a service animal

Any behaviour that does not support a welcoming environment and/or violates the Rules of Conduct may result in cost-recovery charges, suspension of library privileges, exclusion from the Library and prosecution.

These Rules have been approved by the Gaynor Family Regional Library Board.
