PLANNING BOARD REPORT

The Planning Board had a walk through with the engineering firm MRB Group to address the current drainage situation. MRB Group then sent a "Proposal for Professional Services Drainage Study and Concept Design". Their report is as follows:

- I. Background/Understanding
 - The Town of Rose would like to review storm drainage in two key locations which were identified during a site walk in July. A number of residents have expressed drainage concerns and wet basements. Utility record mapping in the studies areas is limited. During the site walk septic odor was also noted in several catch basins near Clinton Avenue indicating a septic system failure or direct connection to the storm system. The study areas for drainage evaluation are noted below:
 - North Rose-Area encompassed by Main Street (NYS Route 414), Caroline Avenue, Gray Street and Clinton Avenue (County Route 257). Drainage in this area appears to be collected in a storm drainage system on Gray Street which flows north toward Clinton Avenue. The existing county storm sewers on Clinton Avenue are shallow in depth. Collected Storm Water is piped north crossing Clinton Avenue and through an existing drainage easement to a farm field and creek tributary.
 - 2. Rose Fireman's Field Drainage along School Street and its flow paths are unknown. Possible path is down Winchell Street. Several catch basins were identified on School Street. Improvements to drainage at the Rose Fireman's Field.
- II. Scope of Services and Compensation
 - A. Data Collection

- 1. Request and review available utility and highway record plans from the Town, Wayne County Highway Department, and NYSDOT.
- 2. Limited field survey of existing structures, culverts and drainage pipe invert elevations within and adjacent to both study areas.
- 3. Utilize most recent available online LiDAR data to obtain 1-foot ground contours.
- 4. One site visit to review the visible condition of the existing drainage infrastructure.

- 1. Utilize the field survey data, LiDAR survey ground contours, and available record plans to prepare an existing drainage schematic servicing the study areas
- 2. Estimate drainage flows and evaluate the existing drainage system capacity.
- 3. Identify existing drainage system deficiencies, and evaluate feasible improvement alternatives.
- 4. Meet with Town to present the existing drainage system capacity analysis and discuss preliminary improvement alternatives.
- 5. Finalize concept level plan of recommended improvements and prepare estimated costs.
- 6. Compile the existing drainage system analysis, recommended improvements, and estimated cost into a letter report and submit to the Town.
