Supervisor Converse opened the Hearing with the Pledge of Allegiance to the Flag.

Supervisor Converse addressed the attendees explaining the Comprehensive Plan and the Hearing for the Comprehensive Plan to any who were not informed.

There being no questions or oppositions to the Comprehensive Plan Hearing, Supervisor Converse closed the Hearing and began the regular Town Board meeting.

## **PRIVLEGE OF THE FLOOR**

Mr. Drazen Gasic, of EDF Renewables, presented the Rosalen Solar and Storage project to the Board. He explained the current solar projects in New York and the benefits to solar energy and storage. They anticipate construction to begin in 2028 with 35% of their project in the Town of Rose and 65% in the Town of Galen. They would be using 25 acres of agricultural land assuring farmers their land would still be functional for agricultural use. Mr. Mark Humbert expressed his concerns explaining what EDF is proposing does not comply with the Town of Rose's current solar Law. He asked Mr. Gasic if the Town said they did not want solar energy and storage, would the Town have a say in the project, to which Mr. Gasic replied, "no". The state can override the requests of the Town because it does not comply with our current solar law. Mr. Gasic and Mr. Humbert continued discussion until it was proposed that Mr. Gasic come again on another day for a meeting, separate from the board meeting, for more questioning.
