Pricing for one (1) Airstream with two (2) attendees 2 years of age and over is \$300\* per night for April 6, 7, 8, 2024 with a three (3) night minimum. Additional guests 2 years of age and over are \$50\* each day for April 6, 7, 8, 2024. Attendees may arrive on April 5, 2024, and/or stay April 9, departing April 10, 2024, at \$100\* per rig each night. April 5 and April 9 are optional and are not part of the 3-night minimum required. If an applicant invites additional visitors aged 2 years or older the lessee will be charged \$50\* per person on April 6, 7, or 8, 2024.

The NTAC Eclipse Event requires a Non-Refundable deposit of \$300.00 at the time of reservation, with the remaining balance due by October 1, 2023.

For security purposes, the NTAC Office Manager must be given the names and ages of additional guests visiting the applicant, and the dates they plan to attend.

Persons under the age of 18 must be under adult supervision.

No Tents – self-contained Airstream trailers, or motorhomes with fully-functioning bathroom facilities only.

Street parking is prohibited, all vehicles must be parked on the lot.

No generators shall be used during this event.
