## REQUIREMENTS

---

### PRE -REQUISTIES

- Must hold a valid and current Class “A” Commercial Driver’s License.
- Must hold a valid and current Medical certificate and pass a USDOT drug screen.
- Provide a 10-year driving record (MVR).
- Have no current or pending license suspensions.

### ORIENTATION

At orientation, you will discuss when you left the trucking industry with a staff member to determine what classroom subjects you will need during your training.

### COMPLETE CLASSES

Day Classes are Monday – Friday (excluding any Holidays) from 8 – 5 daily.

### LODGING

Lodging accommodations are available at a negotiated rate if needed. When enrolling for any of the advanced classes please make us aware if you will require lodging in advance.

## REGISTRATION

**Registration** – Students must be pre-registered for classes. This may be done via email for students who live outside of the local facility area.
