Provide a 10-year MVR.

No current or pending suspensions.

Persons considering this training must be eligible by meeting all CDL driver's license, drug/alcohol and medical requirements as provided in Federal and State regulations prior to the start date of the class.

### COMPLETE CLASSES

Day Classes are Monday – Friday (excluding any Holidays) from 8 – 5 daily.
