

The Southeast Mounted Drill Team Association will be holding an Open Mounted Drill Team Competition November 15-17, 2019 at the Rabun Arena in Tiger, GA. **Please make sure that you thoroughly read our Rulebook which can be found on the SEMDTA website:** <u>www.semdta.org.</u> Show time and Judges meeting time will be announced in an email closer to the show date.

Registration and check-in will begin at 1:00 PM on Friday November 15, 2019. No early check-ins will be allowed and no horses will be stalled prior to check-in. Weekend rate for horse stalls, tack stalls, and RV parking is for Friday and Saturday night. *Our Judges will be Debbie Dunphy and Dan Myers.*

There will be a stall decoration/cleanliness contest. The winning team will receive a free tack stall for the following competition.

Music and introduction must be turned in at registration on Friday. (Please read rules in SEMDTA Rulebook). Your CDs will be briefly tested for compatibility. You will be contacted if there is a compatibility issue.

Entry Forms: *REMINDER*: For awards; please remember that you must compete in the same classes with the identical team name throughout the show year to accumulate points for placings in the State, Regional, National and Overall Division Championships. Awards and points will be accumulated and given per team name.

- Coaches must complete a separate entry form for each team that will be competing. For example: if you have a Floyd County JV and a Floyd County V, you must complete two separate registration forms. Teams cannot be combined into one entry form.
- Release forms and all signatures must be submitted with your registration forms by the due date.

PRACTICE/ARENA TIME: (Please read rules in SEMDTA Rulebook)

Late Entries: Please read rules pertaining to late entries. These will be strictly enforced! NO EXCEPTIONS! *Any entries or payments received after the deadline will receive a 25 point deduction per class entered (see score sheets).*

We accept Checks or Venmo (Linda Heusner@Linda-Heusner-1) for registration received by the deadline. Any payments received after the deadline must be paid in cash.
