



The Southeast Mounted Drill Team Association will be holding an Open and 4-H Mounted Drill Team Competition April 17-19 2026 at the Rabun Arena in Tiger, GA. **Please make sure that you thoroughly read our Rulebook which can be found on the SEMDTA website: www.semdta.org.**

Show Times, Agenda, Order Of Go, Stall Assignments and more will be posted on the SEMDTA website close to show date.

Check-in will begin at 2:00 PM on Friday, April 17, 2026 - no early check-ins will be allowed. There will be a free tack stall drawing. The winning team will receive a free tack stall for the following competition which is June 19-21, 2026. The winning team **MUST** redeem the free tack stall at that show or forfeit it.

Entry Forms: Due by March 12, 2026. As a reminder for awards—please remember that you must compete in the same classes with the identical team name throughout the show series to accumulate points for placings in the Southeast Regional Championships. Awards and points are accumulated and given per team name.

- Coaches must complete a separate entry form for each team that will be competing. For example: if you have a Floyd County JV and a Floyd County V, you must complete two separate registration forms. Teams cannot be combined into one entry form.
- Coaches must submit the 2025-2026 Show Series Release Form and all signatures with their registration forms. If your team competed in the September 2025 show, only new rider signatures are required for the remainder of the show series. (Please read rules in SEMDTA Rulebook).

Class Music & Class Introductions: Due by March 12, 2026 via the SEMDTA website. (Please read rules in SEMDTA Rulebook).

Practice & Arena Time: Sign Up via your Google account. (Please read rules in SEMDTA Rulebook).

Late Entries, Late Music, Late Class Introductions, and/or Late Payments: If received after the deadline date, teams will receive a 25 point deduction per class entered (see score sheets). (Please read rules in SEMDTA Rulebook pertaining to late entries). These will be strictly enforced! **NO EXCEPTIONS!**
