



The Southeast Mounted Drill Team Association will be holding an Open Mounted Drill Team Competition February 21-23, 2025 at the Bulloch County Agriculture Complex Arena in Statesboro, GA. Please make sure that you thoroughly read our Rulebook which can be found on the SEMDTA website: www.semdta.org.

Show time, Agenda and Stall Assignments will be posted on the SEMDTA website close to show date.

Check-in will begin at 2:00 PM on Friday, February 21, 2025 - no early check-ins will be allowed. A drawing will be done for a free tack stall for the following competition, which is April 18-20, 2025.

Entry Forms: **REMINDER:** For awards—please remember that you must compete in the same classes with the identical team name throughout the show year to accumulate points for the National Championship. Awards and points will be accumulated and given per team name.

- Coaches must complete a separate entry form for each team that will be competing. For example: if you have a Floyd County JV and a Floyd County V, you must complete two separate registration forms. Teams cannot be combined into one entry form.
- **NEW!** Coaches must submit the **2024-2025 Show Season Release Form** and all signatures with your registration forms by **January 30, 2025**. *Signatures on this form will be good for one calendar year.* If a new rider comes on board during the year, Coaches must have them sign an SEMDTA release form and submit it before they ride in an SEMDTA competition. A blank release form is available on the SEMDTA website for your use.

Music/Class Introductions: Due by **January 30, 2025** via email. (Please read rules in SEMDTA Rulebook)

Practice/Arena: Sign up for practice via your Google account. (Please read rules in SEMDTA Rulebook).

Late Entries/Late Music/Late Class Introductions: Please read rules pertaining to late entries. These will be strictly enforced! NO EXCEPTIONS! **Any entries or payments received after the deadline will receive a 25 point deduction per class entered (see score sheets).**

We accept Checks (made out to SEMDTA) or VENMO (Linda Heusner@Linda-Heusner -1) for registration received by the deadline. Any payments received after the deadline must be paid in cash.

Check Policy: If your check is dishonored or returned for any reason, we will electronically debit your account for the amount of the check plus a processing fee of \$40.00.
