

## 2A Firearms LLC Standard Consignment Agreement Policy

2A Firearms LLC agrees to accept listed item(s) for consignment sale under the terms of this agreement.

The consignor agrees to place the listed item(s) on consignment with 2A Firearms LLC to offer for sale under the terms of this agreement.

The consignor agrees that the listed item(s) will be with 2A Firearms LLC available for sale for a minimum of 60 days.

2A Firearms LLC will manage and market the listed item(s) for sale according to the following:

- 1. Each item will be visually inspected for noticeable defects.
- 2. Item(s) will be surface maintained and cleaned for best possible retail presentation.
- 3. Item(s) lacking proper retail presentation condition may be disassembled(Field Striped) and internally cleaned, or bathed in appropriate cleaning solution to assist returning the listed item(s) best possible retail presentation. (If this is required a \$25.00 cleaning fee will be assessed)
- 4. Item(s) will be presented at our retail location during the initial 60 period.
- 5. Item(s) may be photographed for display on our website or other marketing protocols may be utilized at 2A Firearms LLC discretion.
- 6. Acceptance of any item for consignment is at the sole discretion of 2A Firearms LLC.

At the end of 45 days, the item(s) initial sale price will be evaluated by 2A Firearms LLC, an adjusted price of not less than the authorized price set forth in this agreement may be used and the item(s) remarketed as stated in lines 4 & 5 of marketing plan listed above.

At the conclusion of the 60 day period, the consigner will be contacted to discuss alternate marketing options, price reduction or return of the item(s) to consignor.

When sale of an item(s) has transacted, the consigner's net amount due will be paid 30 days from the date payment was received and the purchaser has taken possession of the item(s).

- 1. Payment will be presented in hand or mailed to the address of consignor listed on this agreement.
- 2. The consignor is responsible to notify 2A Firearms LLC in writing of any change of address after initiation of this agreement.
- 3. 2A Firearms LLC will calculate the net amount due consigner by:
  - a. Final sale price of listed item(s)
  - b. Less the standard commission of 15% of Final sale price. (Minimum fee is \$50.00)

- c. Less any applicable credit card fees from payment for Final sale price.
- d. Less any necessary cleaning fee assessed in lines 3 of marketing plan listed above.

After the initial 60 day period has transpired and both parties agreeing to continue this agreement, either party has the right to terminate this agreement 10 days after supplying written notice to the other party.

Termination of this agreement without a sale shall be subject to the following:

- 1. Payment by consignor of a \$25.00 Display & Marketing fee.
- 2. Any consigned item(s) that remain with 2A Firearms 90 days after proper termination of this agreement by either party will result in the assessment of a \$25.00 per month storage fee due and payable to 2A Firearms before release of listed item(s).
- 3. For New Hampshire resident consignor to be returned a listed firearm(s), Federal law requires the consignor complete a Form 4473 and accompanying NICS background check. Standard transfer fee shall be due and paid before return of listed firearm(s).
- 4. For non-resident consignor to be returned a listed firearm(s), Federal law requires 2A Firearms LLC to follow all applicable laws for out-of-state firearm(s) sales and ship the firearm(s) to a FFL Dealer of that state, where an NICS check is required to retake possession of the firearm(s). Any NICS check fee will be assessed by your FFL Dealer. Packaging, shipping and insurance charges will apply and must be paid before firearm(s) will be released.
