4. FIRST AID MEASURES

Poisons Information Centre: Phone 131 126

Swallowed: If poisoning occurs, contact a doctor or Poisons Information Centre (Ph 131 126 Aust. wide). If swallowed, do NOT induce vomiting. Give a glass of water. Rinse mouth with water. Never give anything by mouth to an unconscious person.

Eye: Immediately hold the eyes open and wash continuously for at least 15 minutes with fresh running water. Ensure irrigation under eyelids by occasionally lifting the upper and lower lids.
