## SECTION 4: First aid measures

### Description of first aid measures

#### **Extinguishing media**

#### **Advice for firefighters**

**Protective actions during firefighting**                      Avoid breathing fire gases or vapours. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses.
