(Dan) Ross, I have been doing Veteran Service Officer, since August 2005; when I started my first claim with a VFW Service Officer, and it took me 19 months to get it through the VA for payment. As I started talking to Veterans and found out there was a need for someone to assist veterans

with help. In late 2008 was the first I heard about VVA, when I joined another Veteran was taking a course to become an Accredited Veteran Service Officer. I starting enquiring about that and how to take the course. The cost was \$150.00 from the National Veterans Legal Service Plan. I took that and got accredited on March 31; 2009. VVA opened our office at the VA, hospital in Building 58, and a year later we were moved to Building 13, and we are still located there but have been closed since March with the Coronavirus. I have been doing the service Officer work by emails, text messages, phone calls, and local restaurants. I have assisted 100's of veterans from World War II, Korean War, Peace. time, Vietnam Conflict, Desert Storms, and the current conflict. I have assisted veterans and their families collect millions of dollars in disability payments, DIC payments, educational programs, automobile adaptation for handicapped veterans. I have assisted veterans while my wife and I travel across the country when we stop at and RV park in other states.

I have traveled to Phoenix Regional Office, on several occasions over the past 11 years with veterans for hearing before the Traveling Boards and have been very successful in getting the denied verdict changed to a favorable rating. I frequently get phone calls from veterans in other states asking me questions about their claim and what can be done to help them,

My other activities that I have done during the 11 years. I joined VVA as a Life Member 391499, was a member of Gabrielle Giffords, Veterans Advisory Committee, served on the Tucson Advisory Committee for eight years from 2009-2017. Served as Secretary of VVA Chapter 106 in Tucson, AZ from 2009-2012, President from 2012-2014, Secretary from 2014-2016, served as Chaplain for the past 8 years. I attended the National Convention in Louisville, KY, 2009 and in Jacksonville 2013. I also attended VVA Leadership Conference in Tucson, Arizona 2016 and in Palm Springs 2018. I have received the Vietnam Veterans of America Achievement Award, recognized by Representative Martha McSally, Senator Martha McSally for my work with the Veteran Community.

My Military service was in the United States Air Force from October 16, 1963 to October 13, 1967.
