Items required to be presented with submission of the application:

- State of Iowa Annual Mobile Food Vendor License
- Iowa Department of Revenue Permit
- State of Iowa Issued Certification(s)
- Fire Marshall Safety Inspection Approval
- Insurance
- Description of Location(s)
- Written Consent (if applicable)

Please ensure proper up-to-date documentation is provided at all times, as the issued permit will be valid only through current document. Once new up-to-date documentation has been received, a new permit will be issued through the remainder of the year.

State of Iowa Annual Mobile Food Vendor License

Written consent from the property owner(s), Permanent food Establishment owners is required. There is definitive permission given/granted.

- Business owner(s) are not always the property owners.
- If you are vending ONLY in city parks' the issuance of the Mobile Food Vendor Permit is the City's consent. Written consent is
