### NEW BUSINESS

**BLM/ WSDA Assistance Agreement** – Payment in the amount of \$5,000.00 for noxious weed control in Juniper Dunes has been received. Debbie Plummer, Natural Resource Specialist has requested a proposal from us to run through 2022. Todd has submitted a proposal to continue working on the same section.

**State Parks** – We have received payment in the amount of \$16,298.62 for noxious weed work on CPT right of way and in the state parks. We continue to perform follow up kochia spraying in Sacajawea Park and work on the watering system at the pollinator garden. Water hoses have been repaired/replaced several times. New channeled speed bumps will be installed to protect the hose.

**Kahlotus Cell Tower** – Waiting on payment from I.S. in the amount of \$273.56

**Weeds of Focus**- Several landowners have partnered recently on noxious weed control. We have received payments in the amounts of \$252.22 and \$50.00 for yellow starthistle spraying off Murphy Road.

Marcus and Luis were instrumental in persuading two high priority landowners to cooperate in spraying yellow starthistle, Scotch thistle and rush skeletonweed on their properties. FCWB supplied the labor with the stipulation the landowners participate in 2021 cost share program. Payment in the amount of \$666.38 has been received from Larry Olberding for reimbursement of chemical. We are waiting on payment from the other landowner.

**Avista Power** – We have been contacted by Michelle Anderson of Anderson Environmental Consulting on behalf of Avista to discuss the possibility of conducting weed control as part of a restoration project on a section of transmission line that has been replaced. The replaced line runs through the Hanford Reach National Monument and is managed by USFWS.

**Field Sampling** – Update on results of lab analysis for potato damage.
