You will be responsible for your attorney's fees, if any. Any appeal of a judgment from a small claims

tribunal shall be resolved by binding arbitration. The arbitrator shall not conduct class arbitration. The arbitration hearing will be conducted in the county in which this Customer Information Sheet was signed.
