This is your opportunity to be a member of Gallery 782 (an Artist Co-op) located in historic downtown Biloxi in the Pringle Building (corner of Jackson and Ohr). Gallery 782 is a group of professional artists and interested patrons along the Mississippi Gulf Coast who are dedicated to promoting members' work and creating a greater community awareness of the arts and art-related events in the area.

Membership in the gallery is open to artists who meet the standards set by **Gallery 782**, are residents of the Gulf Coast area of Mississippi, qualify through the jurying process, subscribe to the objectives and purposes of the Co-op, pay any applicable dues, agree to abide by the policies, rules, and guidelines of the Co-op, and agree to serve on a committee and participate in scheduled events.

Standards of Gallery 782: To qualify for membership, an artist must demonstrate a professional commitment to the arts through continued production and exhibition of his/her visual art and a dedication to the creative community of the Gulf Coast through participation in local art events.

## Members must:

- Qualify through the jurying process set up by Gallery 782
- Follow all policies, rules, and guidelines of the Co-op

## Benefits:

- Free Booth Space at all Biloxi Main Street Festivals (4 events a year)
- Opportunity to show art in a prestigious co-op/gallery
- Eligibility to be a featured artist
- Collective power in the marketplace
- Opportunity to conduct workshops for fellow artists and/or children.

## Current Dues:

- There is an initial joining fee of \$25 (to be paid once accepted)
- Membership fee is \$60 per month (to be paid every 3 months in advance, which is a total of \$180.00 quarterly). This fee is for artists who fulfill a once a 4 week/month sitting obligation.
- There is also a "non-sitter" membership of \$315.00 quarterly (\$105/month)
- There is a 10% commission on sold art.

**8. Jurying Process**

**Phase I** - *The jurying committee will review your application and photos of your artwork and contact you as to whether you will proceed to Phase II*

**Phase II** - *You will be asked to bring at least five representative examples your original work to the gallery and meet with the committee.*

*After meeting with the jury committee, you will be asked to take your work home with you. You will be notified of the jury committee's decision within one week.*
