W4BS REPEATER SYSTEM

As many of you know, the ARRL has prepared, after 30 months of research, a proposal that they intend to submit to the FCC regarding the restructuring of the amateur licensing process. In short, they are proposing that the code

requirement of 13 WPM be reduced to 5 WPM for all license classes below Advanced. Also they are recommending that the 20-WPM requirement for Extra be reduce to 12 WPM. In addition, the license names would be changed to Class A, B, C, and D. This means that an individual who is an Extra class amateur now would become a Class A amateur. As I said, this is just a synopsis of the proposal that ARRL is planning to submit to the FCC. For a more in-depth description of the proposal I recommend that, those of you that have Internet capability, visit the ARRL "homepage". There you will find the proposal and charts indicating the various changes to frequencies, license names, and code requirements. I am encouraging every amateur to visit the ARRL "homepage" and read about the proposed changes and send your comments to Rick Rodrick (K5UR), Delta Division Director, and/or Henry Leggett (WD4Q), Vice Director of Delta Division. The more information that ARRL has regarding the feelings of their members and the amateur community as a whole, the better they will be able to represent us to the FCC. The first weekend in August we had our FedEx/St. Jude Special Event. I found that operating without the pressure of Field Day gave me another view of amateur radio. I hope that all of you that visited us at the gazebo in Freeman Park in Bartlett enjoyed yourself as much as I did. AMATEUR HARDWARE UPDATE

We are always looking for ways to organize and make the ham shack neater. Electrical outlet face plates are available as blanks for about 20 cents each. By drilling these to mount connectors we can build these on a panel or in the wall to bring in connections from other parts of the house or from outside. This month's project is the OUTLET FACEPLATE DRILLING FIXTURE which allows mounting holes to be drilled in the faceplates without breakage. The faceplates are made from a plastic that cracks easily if stressed while drilling. The fixture supports the faceplate and aids in hole locations for mounting connectors as needed. The fixture is easily built with a few scrap pieces of wood and makes building custom faceplates a lot easier. I will have the OUTLET FACEPLATE DRILLING FIXTURE at the meeting to show and answer questions for those who wish to build their own unit.

AMATEUR PACKET UPDATE

One of the biggest problems on HF digital modes is noise and interference. This prevents received signals from being properly decoded. Now if you have an older TNC you can upgrade to DSP with an add-on DSP filter from MFJ. The

unit is the MFJ-781 which has a DSP with filter selections for Digital modes built right in. The unit offers superior performance to analog filters and is easily hooked up to the audio output of your radio before it reaches the TNC. The MFJ DSP allows better reception of digital signals when conditions are bad. The unit is available for less than \$125.00.
