As you prepare to send your comments to the FCC in reply to NPRM 98-143. It is suggested that all license amateur radio operators prepare comments and send to the FCC. Your comments and thoughts may be the best and will give our license

There is no set format for informal public comments on FCC NPRMs, NOIs and other items. If you want to make a formal "filing", the rules become more formal. On page 15-9 of ARRL's "FCC Rule Book" there are some suggestions, which

1. Use 8.5 x 11 (letter size) paper 2. Include the Docket number or Rulemaking number 3. Include your name and address 4. State your interest in this matter (i.e. "a concerned citizen" etc.) 5. State your position and facts directly, and relate them to your experience 6. Make clear exactly what provisions of the rule are objectionable 7. Support your argument with facts 8. Keep your comments succinct 9. Include an original and four copies 10. Send to: Secretary, Federal Communications

Interested parties may file comments on or before December 1, 1998 and reply comments on or before January 15, 1999. Comments may be filed using the Commission's Electronic Filing System (CEFS) or by filing paper copies as stated above.
