Another year is in the books. I'm sure it has been challenging for all. We had four classes: the Extra Class was under normal circumstances. Then COVID 19 hit so we began the Zoom classes. As a result, our pass rate was somewhat lower than other years and those that did pass were not active. Hopefully, the New Year will bring more activity on the air.

There is no charge for classes, but the student is responsible for the purchase of the license manual and the \$15 ARRL FCC examination fee.

Licenses Earned in 2020 from Delta Classes 20 Technician 8 General 4 Extra

Note:

The current Technician ARRL Ham Radio License Manual Fourth Edition with question pool that became effective July 1, 2018 for four years. This is the new question pool.

The current ARRL General Class License Manual is the Ninth Edition with question pool that became effective July 1, 2019 for four years.

The current ARRL Extra Class License Manual is the Twelfth Edition with question pool that became effective July 1, 2020 for four years.

As of September 3, 2015 there is no longer any charge for Vanity callsigns.

As of late 2019, expired Amateur Radio license holders can get their license back by taking the current Technician exam and show proof of their previous license class. A previous Advanced Class licensee will only be able to get a General Class license.

1. Go to https://wireless2.fcc.gov/UlsEntry/licManager/login.jsp

- 2. Enter your FCC Federal Registration Number (FRN) and Password
 - a. If you do not know your FRN, go to Search box and click on License Click on Amateur; Enter your callsign in Callsign box; Your FRN is in center of page after your name (If you do not know your Password, click on Contact Tech Support after Forgot your Password)
- **3.** In When My Licenses screen comes up, click on **Now** in the green line reading "Change your paper authorization preferences <u>here</u>, or download your official electronic authorizations now"
- **4.** In Under Download Authorizations screen, highlight your callsign in the My Authorization area at the bottom left.
- 5. Click on ADD to right of the highlighted callsign.
- **6.** Highlight your callsign in Authorization to Download and then click on Download on bottom right of screen.
- 7. If pop-ups are blocked, click on Allow One
- 8. Click Open at bottom and Print your License.

An Easy, Inexpensive (Free) Method for Remote Rig Control Submitted by Hugh Wardlaw WB4SLI

If you have had as much fun (if you are a masochist) as I have trying to accomplish Remote Rig Control then you may be interested to another approach to accomplishing this with little outlay of cash. If you have already setup flrig and fldigi then you are 1/3 done. This information is independent of VHF, UHF, or HF operation.

As you may guess flrig is the cornerstone of the setup. If you have flrig setup then go to the Voice portion of the document. Flrig is to be installed on the computer directly attached to the transceiver. W1HKJ has written freeware for rig control and digital operation. To install flrig then go to <u>https://sourceforge.net/projects/fldigi/files/</u> you will be presented with a list of files. The one in which we are

interested now is flrig. Click on flrig to see your different flavors. On my Windows computer I selected flrig-(version)-setup.exe. Download the file and execute it. This will install flrig.

Launch flrig and select the config / setup / transceiver. Select your rig from the dropdown list. Set the serial port through which you will connect to the rig. Set the Baud Rate. On the 7000's it is 19,200 bps. Set the stop bits. My rigs that I use are Icom 7000 series for HF. I can issue a command to operate PTT so I select PTT via CAT command. You may need to select other means to accomplish PTT. The 7000's have built-in USB audio so I selected USB audio. I recommend using a separate USB sound card, if your rig has no internal USB sound card. So that you will not be potentially sending the beeps and other sounds associated with the O/S and Apps. Select Init to apply your selections to the software. It may take a minute.

VOICE

Well you have yourself needing a way to place your voice into the rig remotely. I have had the best success using IP-Sound. Note: this software needs to be on both the server (rig control) computer and the client (remote) computer. First, we need to download the software by going to <u>http://www.iw5edi.com/software/ip-sound</u>. Go to the end of the fifth paragraph where Simone is describing the software. Click on IPS-0.57A to download. Follow the instructions to download.

Go to your downloads folder via File Explorer and right click on IPS-v0.57a-Finale and select Extract All. You will be presented with the contents of folder IPS-v0.57a-Finale. There will be a pdf doc file and an IP-Sound-v0.57a-Setup.exe file in the folder. Double-click on the IP-Sound-v0.57a-Setup.exe file to install the software.

Launch IP-Sound and once it is loaded on the client computer right click on the black area of the screen to setup connection to the server (rig controlling) computer. You can use either the network name or the IP address of the other computer to establish connection.

REMOTE CONTROL

I use TightVNC to control the flrig software remotely. Go to <u>https://www.tightvnc.com/</u> to download the software. This software needs to be on both the client and the server. You will be presented with 64-bit and 32-bit installers. To determine which flavor of Windows you are using click the Start logo and select Setup. Select System and scroll down to About. To the right you will see a lot of information. Look for the Device Specifications Section and look at the line that says System type. It will there say whether you have a 64-bit or 32-bit O/S. Download and install the appropriate version.

Select Start and scroll down to the TightVNC folder. On the server computer click on the folder and select TightVNC server offline setup. If you want password protection of the computer (which I recommend) select the Administration folder and select control operations with a password. Set both types of passwords to something simple that you can remember.

OPERATION

On the server you will need to start flrig and connect to the rig. You should start IP-Sound and TightVNC Server.

On the client start IP_Sound and TightVNC Viewer. Using IP-Sound, in the black box right click on the server and select connect. If everything is setup properly you should hear the transceiver. In TightVNC connect to the server. With this you can control flrig. Familiarize yourself with the controls. You can set modes such as LSB, USB, and FM for voice modes. The PTT button is in the lower right corner. It is click on click off. Next to PTT is the Tuner button. My 7600 has a built-in tuner so that I can kick the tuner as I change bands. If you have one of the LDG tuners specifically supporting your rig (like my 7200) then you should be able to kick the tuner.

Fox Hunting with Software-defined Radio

Fox hunting, or direction finding, is a favorite pastime in the ham radio community where radio operators attempt to triangulate the position of a radio transmission.

While it may have required a large amount of expensive equipment in the past, like most ham radio operations the advent of software-defined radio (SDR) has helped revolutionize this aspect of the hobby as well. [Aaron] shows us how to make use of SDR for direction finding using his custom SDR-based Linux distribution called DragonOS.

We have mentioned DragonOS before, but every iteration seems to add new features. This time it includes implementation of a software package called DF-Aggregator. The software (from [ckoval7]), along with the rest of DragonOS, is loaded onto a set of (typically at least three) networked Raspberry Pis. The networked computers can communicate information about the radio waves they receive, and make direction finding another capable feature found in this distribution.

[Aaron] has a few videos showing the process of setting this up and using it, and all of the software is available for attempting something like this on your own. While the future of ham radio as a hobby does remain in doubt, projects like this which bring classic ham activities to the SDR realm really go a long way to reviving it.





Arecibo Dish

The 1,000 foot (307m) Arecibo Dish in Puerto Rico, used for Amateur Radio Moonbounce (EME) communications and ionospheric experiments, is to be decommissioned

On Space News Jeff Foust @jeff_foust writes:

National Science Foundation announced Nov. 19 it will perform a "controlled decommissioning" of the giant radio telescope at the Arecibo Observatory in Puerto Rico, citing recent damage that made it unsafe to operate or even repair.

In a call with reporters, NSF officials said two broken cables used to support a 900-ton platform suspended over the telescope's 305-meter main dish put the entire structure at risk of collapse. One cable slipped out of its socket in August, falling to the dish below and damaging it, while the second broke Nov. 6.

Both cables are attached to the same tower, one of three surrounding the main dish. "The engineers have advised us that the break of one more cable will result in an uncontrolled collapse of the structure," said Ralph Gaume, director of the NSF's Division of Astronomical Sciences, referring to cables attached to that same tower. That would result in the platform crashing down to the main dish and potentially toppling one or more of the towers.

The giant dish-shaped radio telescope was unlike any other: It sent messages to the stars, listened to the tick-tock of distant pulsars, helped keep Earth safe from asteroids, taught generations of students how to be astronomers, and so much more. This is a major loss.

To me, Dr. Tony Phillips, the loss is personal. I lived and worked at the observatory for more than 5 years in the 1990s while it was still operated by Cornell University. I ran around the dish thousands of times, logged hundreds of hours of observing time, climbed the cat walks and drove Jeeps across the jungle floor beneath the main antenna. The telescope's raw power attracted astronomers from around the world, including many Nobel Laureates; collaborating with them was a life-shaping experience. There may never be another telescope with the same mix of research chops and tropical personality. Good-bye, old friend.

The good news is that as of today RadioShack has officially been purchased by Retail Ecommerce Ventures (REV), giving the troubled company a new lease on life. The downside, at least for folks like us, is that there are no immediate plans to return the iconic electronics retailer to its brick-and-mortar roots.

As the name implies, REV specializes in online retail, having previously revamped the Internet presence of other bankrupt businesses such as Pier 1 Imports and Dressbarn.

While the press release doesn't outright preclude the possibility of new physical RadioShack locations, it's clear that REV believes the future of retail isn't to be found in your local strip mall. As the US mulls further lockdowns in response to the continuing COVID-19 pandemic, it's hard to disagree. There will be millions of bored kids and adults looking for something to do during the long winter nights, and an electronic kit or two shipped to their door might be just the thing.

FCC Headquarters Relocates

FCC Headquarters has moved. The new address is 45 L St. NE, Washington, DC 20554. The change is effective immediately. The FCC announced plans to move last spring, but the transition was delayed by the COVID-19 pandemic.

The FCC, like many federal agencies, has its own zip code, so there will be no disruption in mail delivery sent by USPS to the former address. The FCC still prohibits the delivery of hand-carried documents, and all COVID-19 restrictions or instructions regarding access to FCC facilities remain in place at the new location.

"The FCC continues to balance its efforts to be accessible to the public with the need for heightened security and health and safety measures and encourages the use of the Commission's Electronic Comment Filing System (ECFS) to facilitate the filing of applications and other documents when possible," the FCC said in an October 15 Public Notice.

Due to the pandemic, the move was accomplished by professional movers without the presence of any employees, all of whom had been working from home. An attempt was made during the summer to let employees back into headquarters for a day to pack up their offices and remove personal belongings, but that plan had to be scrapped after several employees tested positive for COVID-19.

Most FCC staff continue to work from home and are not expected to be physically present in their new offices before next June.

In anticipation of the planned move, the FCC last spring also announced the adoption of a new FCC seal. The redesign is the product of an agency-wide contest that solicited proposals from employees and contractors. The revised design incorporates several elements: communications technologies; four stars on the outer seal border, drawing from the legacy of the predecessor Federal Radio Commission (FRC) seal, retaining the three-wire dipole supported by two towers; 18 stars on the shield, recognizing the current number of bureaus and offices; and the eagle and shield, identifying the FCC as a federal government agency.

Official use of the new seal was to begin following completion of the FCC's move from The Portals to its new location on L Street NE.

US Representative Debbie Lesko of Arizona has introduced a resolution designating April 18, 2021, as National Amateur Radio Operators Day, to recognize the important contributions of amateur radio operators.

"Amateur radio operators are critical in times of crisis and our communities are safer thanks to their dedication to sharing important information with the public," Lesko said. She was approached to introduce the resolution by 12-year-old Raymond, N7KCB, from Peoria, Arizona.

"I started Long Distance Responders so I can help prepare the community for emergencies with amateur radio," said Raymond. "There might be a price for a radio, but the ability and knowledge to help someone is truly priceless."

As Lesko's resolution notes, World Amateur Radio Day (WARD) is celebrated annually on April 18 to commemorate the founding of the International Amateur Radio Union (IARU) in 1925, and she said her resolution recognizes the amateur radio community with a national day in the United States in 2021. The resolution cites the Amateur Radio Emergency Service (ARES®) for providing "invaluable emergency communications services following recent natural disasters, including but not limited to helping coordinate disaster relief efforts following Hurricanes Katrina, Wilma, and Maria and other extreme weather disasters."
