President's Corner

There has been a lot going on the past few weeks. It was great to see everyone who came out to participate during Field Day. Just a few hours after Field Day ended, it felt like Field Day 2.0 kicked off. On June 25, 2023 around 7pm, 70-90 mph straight-line winds roared through the Memphis area. About 122,000 in Shelby County lost power, and many were without power for several days. Later that week, heat indices soared to 110-115.

In the Bartlett/Ellendale area, massive trees were uprooted everywhere, and many took out powerlines as they fell. The Ellendale Church of Christ Fellowship Hall, our long-time meeting location, sustained roof damage during the storm. As restoration started throughout the week, many experienced frequent, and sometimes lengthy, cell phone service disruptions. For those without power and Wi-Fi, these cell service disruptions left many without a way to communicate – except those with an Amateur Radio license and radio.

Despite no power, Wi-Fi and cell service, the Delta Club Nightly Information Net consistently met. The Friday following the big storm, there was a widespread, regional Verizon service outage. Despite this outage, we were still able to communicate with others in our community via ham radio.

By the end of the experience, I had been without power for about eight days. Over a week without power was "tough," but I can honestly say that my experiences through Delta Club and ham radio made me better prepared for it. We were lucky enough to get ahold of a generator. For the first few days without power, however, I used my ham radio battery go-box to power several cell phones, flashlights and other devices. It allowed us to charge everything from the comfort and safety of our home versus sitting out in the car at 11pm waiting for things to charge. I even used my battery box to charge my neighbor's phone a few times. In the Ellendale area, it seemed like we had cell service disruptions nearly every day. So, I carried my handheld

radio with me wherever I went. I had comfort knowing I could communicate with others should an emergency arrive during a cell service outage.

I am satisfied how I was able to handle that situation, but I know there are areas that can be improved. I would be remiss to not mention how much I appreciate so many of you for taking the time to give advice and tips over the years — whether that be helping me learn how to program radios or sharing tips about power options and generators. It definitely made a difference that week when everything else seemed to be failing.

Whether you dealt with outages or not, don't let that experience go by without learning something from it. What did you do well? What can you do to be better prepared next time? Is there anything as a club that we can try to do to help you better prepare, such as offering specific programs or events? How can you share your experiences to encourage your family, friends and neighbors to check ham radio out as well?

There will be more power outages. There will be more cell service outages. It's a matter of *when* and not *if* it will happen. So, how can you be prepared for it? See you all Tuesday!

DARC Board of Directors Meeting Minutes for July 5, 2023

The regular monthly meeting of the Delta Amateur Radio Club Board of Directors was held on Wednesday, July 5, 2023 at 6:30 PM on a Zoom video conference call, with the President serving as chair and the Secretary being present. President Mary Jean Hall called the meeting to order.

Unfinished Business

Mary Jean Hall KY4FB gave a recap of Field Day that took place on June 24 and 25. Joe Lowenthal WA4OVO indicated that there was a total of 60 people sign in for the event. It was also agreed that Nashoba and Delta Club would split the cost of Field Day as MARA contributed the vast majority of food and snacks to the event.

Joe Lowenthal WA4OVO gave an update on the bus for Huntsville Hamfest on August 19. The bus has been reserved and 11 people have paid thus far. A discussion was held on the minimum number of people required for the trip to be financially viable. Estimates were between 25 and 28 attendees. The decision on the minimum requirement is being postponed pending the interest shown at the July member meeting. The club has also paid for two tables at the convention center to be used for display of estate equipment for sale.

New Business

Jim Martin KD4FUU reviewed the treasurer's report with the group.

Paul Broom KY4MX presented 1 new member and 4 renewal applications. Joe Lowenthal WA4OVO moved that all applications be approved, with Barry McDonald W5CJ seconding the motion. The motion passed with no objections.

Ty McMahan KX4MQ submitted a proposal to the Board to replace one of the existing analog repeaters with a Motorola DMR repeater and linking it to NWS Memphis. While there was much interest in pursuing this, given the current issues with 146.82 and potential issues with the 443.700 repeaters, it was decided to defer further action on this to a later date.

Board/Officer Reports

Barry McDonald W5CJ had nothing to report.

Joe Lowenthal gave an update on the search for temporary meeting space given the inability to use the regular facility due to recent storm damage. He has reached out to the Mid-America Theological Seminary across from Bellevue Baptist Church and also the Appling Farms Station of the Memphis Police Department. Other potential locations discussed were the sanctuary at Ellendale Church or Christ and the Red Cross offices on Madison. After discussion it was decided to hold on other options pending a response from the Seminary. (**Note:** Subsequent to the Board meeting, approval has been obtained to have the July meeting at the Mid-America Theological Seminary, 2095 Appling Rd, Memphis TN 38016. The meeting will be held in the Betty Howard Special Events room, with testing being conducted in room B-201.)

Mary Jean Hall KY4FB and Joe Lowenthal WA4OVO went to the church and moved the Delta Club equipment and supplies to temporary storage at Mary Jean's house. The plan is to go through everything and organize before moving to longer-term storage at Steve Frazier's father's KK4VPT house. Scott Adams KM4PMU will be storing meeting snacks and supplies.

Joe Lowenthal WA4VO gave an update on the upcoming Technician Training class that will be held for 6 Monday night's starting on July 10. He currently has 13 students enrolled and plans to cutoff enrollment at 15. He will be looking to find a place to do testing on August 7. He also alerted Bob Vawter KW4RJ of the need to change locations for the monthly testing prior to meetings.

John Reiners KN4BVH announced that this month's program would be about Emergency Power. It will be an interactive program with several members talking about how they were able to utilize emergency power during the recent grid outages.

Scott Adams KM4PMU had nothing to report.

Mike Harrison KM4MRW indicated that he is waiting on information for Sparks which will go out this weekend.

Perry Hayes N4GJ indicated that the recent efforts to recognize visitors and new members has been well received.

Mary Jean Hall KY4FB adjourned the meeting at 7:52 pm. The next regular Board of Directors meeting is scheduled for Tuesday, August 1, 2023, at 6:30 PM on Zoom.

DARC Meeting Minutes for June 13, 2023

Call to Order and Opening Remarks

The regular monthly meeting of the Delta Amateur Radio Club was held on Tuesday, June 13, 2023, at 7:00 PM at the Ellendale Church of Christ, with the President serving as chair and the Secretary being present. Club President Mary Jean Hall KY4FB called the meeting to order and then welcomed everyone to the meeting. At least 43 members and guests were present for the meeting.

Mary Jean Hall KY4FB recognized recent new members of the Delta Club and asked that everyone greet them during a break or after the meeting. She then took a roll call of those present and reminded everyone to sign in on the membership roster and also to sign one ticket for the November drawing.

Minutes and Treasurer's Report

Ham Hilliard W4GMM moved to approve the Treasurer's Report and Minutes as published in Sparks. Ned Savage KA4BLL seconded the motion. The motion was adopted by the club without objection.

Announcements

Bob Vawter KW4RJ gave the VE update which included one upgrade to General during premeeting testing.

Joe Lowenthal WA4OVO gave an update on future training. A Technician training class will be starting on Monday in July 10, running for 6 Monday nights from 6:15 to 9:30. The class will be held in person at the Appling Farms Station of the Memphis Police Department, except for the 5th

class on August 7, which will be held at a location still to be determined. He asked that interested individuals email him at WA4OVO@gmail.com with the subject line "Tech Class" with their name, email address and cell phone number. There are currently 7 students signed up for the class.

Joe Lowenthal WA4OVO provided an update on the bus for the Huntsville Hamfest that will be on August 19th. The bus will leave from the Germantown Baptist Church parking lot at 6:30 am and will return at approximately 8:00 pm. The fare for the trip is \$99 per person if paid by July 12th, increasing to \$119 after that date. The fare includes the bus transportation, soft drink and water, snacks and breakfast biscuits on the bus, and the \$15 Hamfest admission. He also pointed out that concessions at the Von Braun center will only accept credit/debit cards this year. There are currently 7 people paid, and with 2 or 3 others that have expressed interest. With the current level of interest in the trip being low, a determination will be made after the July meeting as to whether or not the trip will be held. Approximately 28 people are needed in order for the trip to be viable from a financial perspective.

Mary Jean Hall KY4FB gave an update on Field Day which is coming up the fourth weekend in June (June 24-25). It will run from 1:00 PM on Saturday to 1:00 PM on Sunday. The Delta Club is partnering with the Nashoba Amateur Radio Club, the Midsouth Amateur Radio Association (MARA) and the Shelby County Amateur Radio Emergency Service (ARES) for the event which will be held at the Germantown Municipal Park. Delta Ham License Training, 2023

There is no charge for classes, but the student is responsible for the purchase of the license manual and the \$15 ARRL FCC examination fee. The FCC implemented a \$35 administration fee on April 19, 2022.

If you want to take a class, send an email to Joe at wa4ovo@gmail.com with the class name; ie, Tech Class, General Class, or Extra Class, on the Subject line and name, callsign if you have one, email address, and cellphone number in the text.

Licenses Earned in 2023 from Delta Classes

3 Technician1 General3 Extra

Note:

As of April 19, 2022 there is a \$35 FCC application fee for new hams, renewals, Vanity callsigns, etc except for license upgrade, systematic callsign issue, name, address or email changes. This is in addition to the \$15 ARRL VEC FCC exam fee.

The new Technician ARRL Ham Radio License Manual is the Fifth Edition with question pool that becomes effective July 1, 2022 for four years.

The current ARRL General Class License Manual is the Ninth Edition with question pool that became effective July 1, 2019 for four years.

The current ARRL Extra Class License Manual is the Twelfth Edition with question pool that became effective July 1, 2020 for four years. This question pool will expire on June 30, 2023,

As of late 2019, expired Amateur Radio license holders can get their license back by taking the current Technician exam and show proof of their previous license class. A previous Advanced Class licensee will only be able to get a General Class license.

All classes will be 3-1/4 to 4 hours long for six or seven sessions; one per week on a week night 6:15pm-9:30pm or Saturday day 9am-1pm.

The next **Extra Class** license class will probably start in early January 2024

Tech Class 3-23 – July 10 – August 14, 2023

The first four classes will be instructional and the sixth class will be informational on FM radio basics, APRS, satellite, and digital modes the students can operate on. Classes 1,2,3,4 and 6 will be at the Memphis Police Department Appling Farms Station precinct, 6850 Appling Farms Pkwy, Memphis. The fifth class on August 7th will be a review of the 399 questions and answers in the FCC question pool with an opportunity to take the FCC exam(s) at a location to be determined. Meet the Lithium-Sulfur Battery Submitted by Bob Vawter, KW4RJ

The lithium-sulfur (Li-S) battery has been under development for several years now and it is looking like it could be the next big thing in battery technology. This type of battery has a lot of potential advantages over traditional lithium-ion (Li-ion) batteries, including performance at extreme temperatures, significant weight reduction and low cost.

There is still some work to be done before the Li-S battery is ready for mass production and commercialization, but this type of battery is looking like it could become a mainstream solution in the near-future.

How do Li-S batteries work?

These are a type of rechargeable battery that could challenge Li-ion technology for dominance due to their high energy density. The batteries use sulfur as the cathode and lithium metal as the anode with a solid electrolyte between them. Due to the low cost and abundance of sulfur, Li-S batteries present an economically viable alternative to traditional Li-ion batteries, which mostly utilize cobalt in its cathode material.

So how do these Li-S batteries work? During the charging process, a Li ion is oxidized and becomes an electron; this electron then travels to the cathode. The sulfur atoms in the cathode react with the Li ion and form polysulfide molecules, which act as a bridge between two Li ions.

This initiates eight sulfur atoms to form a ring and consecutively trigger a reduction reaction to gradually shorten and become linear structures of lithium sulfide. During discharging, oxidation occurs in the reverse order — converting back into polysulfide molecules, which again transfer electrons from one side of the battery to another. This process releases energy in the form of electricity.

Why are Li-S batteries solid-state?

Li-S cells are solid state, meaning they do not require the liquid electrolyte found in traditional Li-ion cells. This gives them a number of advantages, including higher energy density and better safety than their liquid counterparts.

What makes Li-S cells solid state is their unique structure. Unlike traditional Li-ion cells, Li-S batteries have a bipolar architecture, with both cathode and anode materials located on either

side of the separator. The cathode material is typically sulfur, and the anode material can be lithium metal or a lithium alloy. The active materials are then held in place by a solid separator, typically made of polyethylene or other polymer material.

The lack of liquid electrolyte in Li-S cells gives them several physical advantages over other types of batteries. Solid state batteries can hold more energy due to their higher storage density. Additionally, since there is no liquid electrolyte present, the risk of short circuiting and thermal runaway is greatly reduced. This makes them far safer than traditional cells, which can catch fire if punctured or damaged.

Advantages of Li-S over Li-ion batteries

Li-S batteries are the next generation of energy storage technology that offer unprecedented advantages over traditional Li-ion batteries. The unique combination of lighter weight, higher energy density, increased safety, lower cost and energy to produce, and superior performance in weathered conditions make Li-S an ideal choice for many applications.

One major advantage of Li-S is its unprecedented energy density. With a theoretical capacity of up to 2,500 Wh/kg — significantly more than most Li-ion cells — it can store twice as much power in a single battery. This significantly reduces the size and weight of the battery while providing maximum power output. Furthermore, this high energy density translates into a longer range for electric vehicles (EVs), making Li-S batteries ideal for transportation.

Li-S is also much more cost effective and requires less energy to produce than Li-ion batteries. Material costs are up to 70% lower due to the use of sulfur as an active material, which reduces the need for expensive rare Earth materials used in Li-ion cells. Additionally, fewer components and simpler production processes result in reduced energy costs and improved sustainability compared with traditional batteries.

The stability of Li-S batteries is also impressive. Under extreme conditions such as temperatures of -70° C and under 1/25 atmospheric pressure, the performance remains stable. This allows them to be used in applications where a traditional Li-ion battery could not survive, making them highly versatile and useful for various industries.

Summary

The combination of these advantages makes Li-S batteries an ideal choice for many applications ranging from consumer electronics to EVs and more. Their low cost, energy density, sustainability, superior performance in weathered conditions, and unparalleled safety make them a smart alternative to traditional Li-ion cells.

The Li-S battery is a serious contender for becoming the next-gen battery, as these boast many advantages over the current version, the Li-ion battery. Some of these advantages include having a higher energy density and being more environmentally friendly.

Even though there are some challenges that need to be faced before mass production can begin, such as cycle life and cost, it is clear that the potential benefits outweigh the negatives.



Packet Update By: James Butler KB4LJV

We are always connecting other devices to our computers. The newest standard for this connection is the USB-C. The speed the connection it has is much greater than older connectors. USB-C stands for universal serial bus type C. The connector size is smaller to allow use on smaller electronics. The connector can also carry video and audio information for hookup to TVs and computer monitors via HDMI. For data they make a USB-A to USB-C adapter to go to older systems. The companies also make a cable to allow for an HDMI video connection. If you want to have it all they have the ultimate hub which has a USB-A connection, 2 USB-C connections, HDMI video connection, power supply input for computer, SD card connection, and Ethernet connection. This interface on newer computers is very fast and versatile. To see all the USB-C adapters you can get do a search on Ebay for a "USB-C adapter".



Amateur Hardware Update By: James Butler KB4LJV

Many amateurs are looking for a cheap and small QRP antenna they can run in the field. MFJ Enterprises has developed a small QRP loop antenna tuner for portable use. The small box has two wire nuts to hook up the loop of wire you supply. The box has a 50 ohm connection from the radio. The length of wire you supply for the loop is determined by the band you want to work. MFJ has the suggested lengths in the manual. The MFJ-9232 operates on 40 through 10 meters with the proper wire length. 80 meters is possible with limited bandwidth. The power limit for the tuner is 25 watts. The MFJ manual also explains how to adjust the tuner for best operation. MFJ even allows you to go to their site and download the manual for the MFJ-9232 so you can see all the information about it before you buy.
