DARC Board of Directors Meeting Minutes

DARC Board of Directors Meeting Minutes for May 4, 2021

Attendees: Steve Frazier KK4VPT, Mary Jean Hall KY4FB, Carolyn Horne KX4QF, Jim Martin KD4FUU, Joe Lowenthal WA4OVO, Mike Harrison KM4MRW, Ian Lucas KN4OEK, Ray Cole KX5RC, Scott Adams KM4PMU, and Barry McDonald W5CJ.

Absent: Len Grice W4MKS.

The regular monthly meeting of the Delta Amateur Radio Club Board of Directors was held on Tuesday, May 4th, 2021 at 6:30 PM on a Zoom video conference call, with the President serving as chair and the Secretary being present. President Steve Frazier KK4VPT called the meeting to order. Due to the COVID-19 Pandemic, the board met online to abide by state and local guidelines.

Joe Lowenthal said he is negotiating prices for the Huntsville Hamfest Bus Trip with Cline Tours. Regarding training, he is looking at starting a Tech Class either the last Thursday in June, two days before Field Day, or July 8th, and finishing August 12th. Junk-in-the-Trunk netted about \$90-100. He sold some of Bill Stevens equipment. Joe Lowenthal said we will have tables at the Huntsville Hamfest and items will all be marked and priced. Ellendale Church of Christ had full services Sunday for the first time since the lockdowns so we may possibly have in-person meetings there beginning in June or July. Scott Adams said we have snacks left but questioned whether we should serve them since people would have to remove their masks.

Ian Lucas said Bob Heil K9EID is booked to do a Zoom presentation on Ham Radio Audio at the May Membership Meeting. The June program has historically been centered around Field Day topics such as logging programs. Steve Frazier said he will put together a video on Field Day activities.

Steve Frazier discussed the prospective venue for Field Day 2021 in the park behind Germantown City Hall.

Barry McDonald reported that a DARC member has suggested we look into running WIRES-X 'Wide-coverage Internet Repeater Enhancement System' on the old Bellevue Repeater at Brunswick Tower. The Club would need to invest in a Yaesu FTM300DR radio and an extra antenna and mast to run remotely from someone's home QTH, where it would connect to a Yaesu HRI-200 WIRES-X internet to RF linking system. The total investment would be just over \$1000. The Board discussed the merits of adding another WIRES-X repeater in the area. Barry McDonald wanted to know who would be responsible for running and maintaining the system. Steve Frazier said if there is enough interest from Club members, we will follow up on it.

Carolyn Horne read the new and renewed membership requests. She made a motion to accept them. Ian Lucas seconded the motion. The motion to approve these members passed. She printed a reference copy of the W4BS FCC license to abide by the Club's by-laws and saved a digital copy as backup. The Board addressed the issue of a member not receiving SPARKS and Zoom link emails where the email address on the membership list is correct. Mike Harrison said he will verify this when he sends out the May edition. Carolyn Horne noticed in the October 2020 QST magazine pages 80-82 are dedicated to recipients of various ARRL Foundation scholarships. She wondered if the Delta Club would be interested in starting up a Delta Amateur Radio Club Scholarship Fund run by the ARRL Foundation. It may be a way to generate interest in Amateur Radio among area youth and put our Club's name out there. All recipients must hold valid FCC Amateur Radio licenses. See www.arrl.org/arrl-foundation and www.arrl.org/scholarship-program.

Jim Martin read the Treasurer's Report. We took in \$120 for memberships this month. Jim Martin said he still needs to set up a meeting with Steve Frazier and the bank to change the name on the club's account since he will need to issue some checks soon. Joe Lowenthal made a few deposits for Franklin Estate sales. In total \$635 was added to our account.

Jim Martin received four membership application forms in our P.O. Box and forwarded pdf versions of them to Carolyn Horne for processing. Of the applications, two were new and two were renewals.

The Board agreed that about half of our excess cash-on-hand should be moved into a CD.

Mary Jean Hall is working on updating our by-laws. The board held a special ad-hoc meeting on Thursday, April 22 at 7 PM. Another meeting is scheduled for Thursday, May 13 at 6:30 PM. She mentioned getting Club shirts made up again. Steve Frazier said he will bring it up at the members' meeting.

Mike Harrison is working on the current issue of SPARKS. He asked if the Board wanted to run any special announcements this month such as Field Day, June 26-27 1 PM – 1 PM. He received info from Bob Vawter KW4RJ, Joe Lowenthal and others to include in this month's edition. The website will be updated for the next meeting. Steve Frazier mentioned that he is still getting regular emails from register.com about our web domain. He said we are in good standing for another few years, until 2023.

Steve Frazier adjourned the meeting at 7:33 PM. The next regular Board of Directors meeting is scheduled for Tuesday, June 1, 2021 at 6:30 PM either in person or on Zoom.

DARC Meeting Minutes for April 13, 2021

Call to Order and Opening Remarks

The regular monthly meeting of the Delta Amateur Radio Club was held on Tuesday, April 13, 2021 at 7:00 p.m. on a Zoom video conference call, with the President serving as chair and the Secretary being present. Club President Steve Frazier KK4VPT called the meeting to order and then welcomed everyone to the meeting. Due to the COVID-19 Pandemic, the club met online to abide by state and local guidelines, marking one year of officially doing this online. At least 55 members and guests were present for the meeting. Steve Frazier KK4VPT addressed the question of when we would be able to meet again in person. He referred us to the President's Corner article in SPARKS, which said we need to follow the CDC's guidelines.

Minutes and Treasurer's Report

Ham Hilliard W4GMM moved to "approve the Treasurer's Report and Minutes as published in Sparks." Len Grice W4MKS seconded the motion. The motion was adopted by the club without objection.

Announcements

John Reiners KN4BVH said that the April ARES meeting is in two weeks and he is sending out the Zoom link for that. He will be going over the SKYWARN Storm Spotter training which took place in March through the NWS. He said he hoped everyone got to take in at least the basic class. He will also be discussing the organizing module, Spotter Network Operations. The NWS 2021 training modules will be available on YouTube and he will send out the links to them.

Barry McDonald W5CJ said that the Methodist North repeater and APRS digipeater located there were both down due to severe storms and lightning strikes. One antenna blew apart but he and Rick Tillman WA4NVM were able to retrieve some parts and put them back together using other parts from another project. They are both back in service. Barry McDonald W5CJ shared some photos that Rick Tillman WA4NVM took at the site, demonstrating what lightning can do to an antenna!

Rick Tillman WA4NVM reminded us that there is a Junk-in-the-Trunk taking place in the parking lot of the Ellendale Church of Christ on May 1 from 9 AM to 1 PM. He also

reminded people that as we enter the severe weather season make sure your batteries are charged for your go-kit.

Joe Lowenthal WA4OVO announced that at the Tech class 2-21 test session on April 5th twelve students passed. Three got General. One student, Park Dodge Al5CY, got Tech, General and Extra. In March, one student, Ina Wiehl KY4GA, ran the table for her Tech, General and Extra as well. Thirteen out of eighteen students got a license. Several will be testing later. Three others tested, including two from CBU, and got their Tech license, so all nine in the CBU Tech Review Class this semester have passed. Bob White's Al4GI grandson, Jacob White KO4OWM got a Tech License. The next Tech class is starting in late June to early July. Joe Lowenthal WA4OVO will announce the schedule sometime in May. He noted that classes take about six months of work with prep, getting the instructors, teaching, testing, and licensing activities. We sure thank Joe for all his hard work.

Joe Lowenthal WA4OVO discussed the upcoming Huntsville Hamfest. If anyone is interested let him know. Seventeen people are interested with three more from his class saying it was a possibility for them. We need thirty-five on the bus to make it worthwhile, so we are about halfway there. The cost will be \$70 or \$75 each. Steve Frazier KK4VPT encouraged everyone to get the experience of going to Huntsville. It's a big deal and we are lucky to be located so close to such an event. Joe Lowenthal WA4OVO said if you plan on going to send an email to wa4ovo@gmail.com with the subject 'Huntsville Hamfest' with your email, name, and cell phone number. The bus will leave at 6:30 AM from Germantown Baptist Church and arrive about 9:45 AM at the Von Braun Center loading dock. The fee will include two Danver's breakfast biscuits (ham or bacon), drinking water, soda, biscuits, cookies and crackers, and some fruit available on the way down and back and during the day. He will give you event tickets and buttons at the bus. You need to fill out that ticket to put in the barrel for the prize drawing. The bus is available for stowing your gear and provides a nice comfortable seat in which to rest. Steve Frazier KK4VPT said that not only are there good vendors but some good seminars are offered on a variety of interesting topics. He said he has taken the bus and driven himself and he found the drive back was tiring after a long day at the Hamfest. He would recommend taking the bus.

Ham Hilliard W4GMM asked if there was any talk about Field Day. Steve Frazier KK4VPT said Fred Miller, one of our main contacts for doing events in Germantown, phoned him, and told him we will not be able to do it at Germantown Park because of the Horse Shows. He is going to find out if we can do it at the Park behind Germantown City Hall and will get back to him about that. There is a pavilion and restrooms, along with some trees in which to string up antennas. It's where the July 4th fireworks are set off.

Bill Flanagan KK4VPS said there is a gazebo there, which would provide some relief from the direct sun. Fred Miller said that because it's outside he thinks it's going to work, amid COVID restrictions. For more information on Field Day, June 26-27th, see <u>Field Day (arrl.org)</u>.

Barry McDonald W5CJ added that he had fixed the time-out issue on the 146.82 repeater. The repeater had a time-out programmed for two minutes, while the controller was set at three minutes. This caused the repeater to cut out with no warning if the two minutes was surpassed without the repeater being reset. The controller does give a warning. So, he set the time-out to four minutes on the repeater, explaining that he didn't want to remove the time-out from the repeater entirely in case something knocked out the controller, causing the repeater to transmit continuously, which happened in the past on another repeater.

Discussion / Program

Ian Lucas KN4OEK gave a presentation on 'VHF, UHF and Microwave Propagation', a YouTube video by Dave Casler KE0OG. This was a session from Dave's online Amateur Extra class, Lesson 10-4.

There was a lively discussion from seasoned Delta Club Ham's like Pat Lane W4OQG, Rick Tillman WA4NVM and Damon Runion WA4HFN, who had quite a bit of experience in propagation using auroras, meteor scatter, moon bounce and the like. They encouraged us to investigate further as the video just served up enough to whet our appetite.

Steve Frazier KK4VPT opened the floor for any questions. Park Dodge Al5CY had two questions 1) Barry mentioned repeater drop-out. What does that mean? 2) Dave Casler KE0OG mentioned meteor scatter using FSK441 and the Extra test mentioned using MSK144 for that. What is the difference and is that something in the radio hardware or software based? Barry McDonald W5CJ answered the first question by saying that it's just a timing issue, the controller will give a tone which he calls the 'kerchunk' and after that you will hear the repeater stop transmitting, which is the drop-out. You must wait a second or two after the tone to reset the repeater. Ian Lucas KN4OEK and Rick Tillman WA4NVM answered the second question. These modes are software based and are available by downloading Joe Taylor K1JT's Weak Signal Communication Software 'WSJT-X' suite from WSJT Home Page (princeton.edu). Earlier version WSJT incorporated FSK441, while WSJT-X is a later development that incorporates MSK144, both of these protocols being used for meteor scatter operations.

Joe Lowenthal WA4OVO said that May 8th is Armed Forces Communications Day. The ARRL puts out the military frequencies where Hams can listen. Ham Hilliard W4GMM said there was an article in the May 2021 QST magazine about these MARS programs. They will release a list of the participating stations after April 19th. Also, during the 1st week of the month until the end of the year they will be transmitting on 5Mhz, Channel 1 voice mode to regular Hams. MARS liaisons will pass on a list of those contacts to the military. The military will give operators a frequency they will listen to on the Ham bands in sort of a crossband exercise. From Sunday thru Wednesday, it will be Air Force MARS, then Thursday thru Saturday Army MARS.

Ian Lucas KN4OEK reminded us of the Museum Ships weekend event the 1st Saturday in June. There are about fifty participating ship stations. He will send a link to Mike Harrison KM4MRW, to publish in SPARKS. Joe Lowenthal WA4OVO talked about being a special event operator in Maine at the USS Thrasher Memorial during Ships on the Air that honored the submarine that was lost in 1963 during a training exercise. He made contact with a station who knew some members of the Thrasher crew and a naval pilot who was part of the search at sea operation.

Closing Remarks

Steve Frazier KK4VPT said that this Zoom membership meeting will be available on YouTube this week. To get to our YouTube channel search for Delta Amateur Radio.

Ian Lucas KN4OEK announced that Bob Heil of Heil Audio <u>Heil Amateur Radio - Ham Radio Receivers - Mics - Headsets - Accessories (heilhamradio.com)</u> will give a presentation on Configuring and Optimizing Your Audio for Ham Radio.

Delta Club President Steve Frazier KK4VPT adjourned the meeting at 8:24 p.m.

Coming soon will be a \$35 FCC application fee for new hams, renewals, upgrades, etc except for address or email changes.

The current Technician ARRL Ham Radio License Manual Fourth Edition with question pool that became effective July 1, 2018 for four years. This is the new question pool.

The current ARRL General Class License Manual is the Ninth Edition with question pool that became effective July 1, 2019 for four years.

The current ARRL Extra Class License Manual is the Twelfth Edition with question pool that became effective July 1, 2020 for four years.

As of September 3, 2015 there is no longer any charge for Vanity callsigns.

As of late 2019, expired Amateur Radio license holders can get their license back by taking the current Technician exam and show proof of their previous license class. A previous Advanced Class licensee will only be able to get a General Class license.

- 1. Go to https://wireless2.fcc.gov/UlsEntry/licManager/login.jsp
- 2. Enter your FCC Federal Registration Number (FRN) and Password
 - a. If you do not know your FRN, go to Search box and click on License Click on Amateur; Enter your callsign in Callsign box; Your FRN is in center of page after your name (If you do not know your Password, click on Contact Tech Support after Forgot your Password)
- **3.** In When My Licenses screen comes up, click on **Now** in the green line reading "Change your paper authorization preferences <u>here</u>, or download your official electronic authorizations now"
- **4.** In Under Download Authorizations screen, highlight your callsign in the My Authorization area at the bottom left.
- **5.** Click on ADD to right of the highlighted callsign.
- **6.** Highlight your callsign in Authorization to Download and then click on Download on bottom right of screen.
- 7. If pop-ups are blocked, click on Allow One
- **8.** Click Open at bottom and Print your License.

One of the new ways to make parts is with 3D printing. Companies are now using 3D printing to make parts for sale. One new item that is now for sale are 3D printed Morse code paddle kits. These are sold in kit form with all the parts included. They need to be assembled to make them operational. They have three different sizes you can buy. The two larger sizes have magnets on the case bottoms to attach to a steel plate or radio. The kits just require mounting parts and soldering wires to the output jack. When operating we can use many types of antennas. One type we use is a wire antenna. We have different kinds of wire antennas. One type is the off- center fed antenna. This type of wire antenna can cover multiple bands. Buckmaster offers the "DX-OCF" 7 band antenna. The unit covers 80,75,40,20,17,12,10, and 6 meters. Buckmaster builds the antenna with heavy duty wire and connectors for a long life in the weather outdoors. They offer a 300 watt and a 3000 watt version. The antenna is completely assembled and ready to install. The antenna is 135 feet long. They also have the balun at the feed point ready to attach to your coax. FCC Auto-Registration Feature for Exam Applicants to be Discontinued Submitted By: Bob Vawter KW4RJ

Auto-registration in the FCC Commission Registration System (CORES) amateur radio exam for candidates using a Social Security number will be discontinued on May 20, 2021. Applicants must use an FCC Registration Number (FRN) for all license transactions with the FCC. Examinees must register in CORES and receive an FRN before exam day. Starting on May 20, electronic batch filed applications that do not include a candidate's FRN will be rejected. The Social Security/Licensee ID Field will be disabled. An instructional video provides step-by-step instructions on how to establish a CORES account, which is necessary for licensees to make administrative updates and download electronic license authorizations. After June 29, all filers must provide an email address on all applications. When an email is provided, applicants will receive an official electronic copy of their licenses once granted (allow incoming email from authorizations@fcc.gov). If no email is provided when filing on or after June 29, applications will be rejected. ARRL VEC suggests that those without access to email to use the email address of a family member or friend.

Licensees need to log in to the Universal Licensing System (ULS) to <u>download their authorizations</u>. The FCC no longer issues paper copies. — *Thanks to the FCC*
